I, SI Partha Kumar Bhunia, O/C Arsha PS do hereby lodge this FIR as suo-moto against (1) Jalil Ansary S/O Naru Ansary of Dhanara (2) Brihaspati Mahato S/O Bhagat Mahato of Hinduhir (3) Dhiren Mahato S/O- Nitai Mahato (4) Sangram Mahato S/O Borobabu Mahato (5) Alauddin Ansary S/O not known (6) Kishan Kumar S/O- Santosh Kumar (7) Swarup Mahato S/O Padmalochan Mahato Sl. No. 3 to 7 all are vill- Dhanara, PS- Arsha, Dist- Purulia and approx 100 villagers of Dhanara village and Hinduhir village to the effect that today at around 17:25 hrs received a telephonic information that some person had blocked Purulia Tata Road (NH 32) near Dhanara more without any prior information or permission and a huge numbers of vehicles including Public buses and State Buses, Small vehicle, Ambulance, Motorcycles got obstructed. Accordingly the fact noted in GD vide Arsha PS G.D.E No- 739, dtd- 20/09/21 and directed mobile office ASI Janardan Kumar to attend at Dhanara more and also myself along with PSI Avijit Mondal and force vide Arsha PS C.C No-1947/21, dtd- 20/09/21 and Arsha PS G.D E No- 740, rushed to the spots and about 18.15 hrs we reached at Dhanara more found that a large numbers of vehicles were obstructed in a queue and approx 100 persons had blocked the road by placing big stones, Wooden Log etc. and they were sitting on the road with demand of electricity. The mob was unruly. I tried to convince them but they were reluctant and obstinate to hear me. I asked them to disperse in loud and clear voice but they did not pay any heed to my words. I declared them as unlawful assembly but they did not care a fig. But in compare to the mob we were insufficient in number to overpower them. So there was no option but to wait. We started waiting and trying to convince them to clear the road for the interest of common people but all our endeavor went in air. They willfully was doing this blockade with intent to injuriously affect the National Highway causing extreme inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for at least 03 hrs and at last they withdrew it at around 20:30 hrs.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer. Hence I do record Arsha PS Case No-96/21, dtd- 20/09/21, U/S-143/188/283/34 IPC and Section 8B of National Highway Act 1956 as suo-moto against (1) Jalil Ansary S/O Naru Ansary of Dhanara (2) Brihaspati Mahato S/O Bhagat Mahato of Hinduhir (3) Dhiren Mahato S/O- Nitai Mahato of vill- Dhanara (4) Sangram Mahato S/O Borobabu Mahato of vill- Dhanara(5) Alauddin Ansary S/O not known of Dhanara (6) Kishan Kumar S/O- Santosh Kumar of village Dhanara, (7) Swarup Mahato S/O Padmalochan Mahato of village- Dhanara, All are of PS-Arsha, Dist- Purulia and directed SI Anirban Dutta to investigate the case.
