Sir,

I, SI Uttam Kr. Mandal of Arsha PS do here by lodge a complaint as suo-moto against some unknown person/persons to the effect that today at about 08.35 hrs received an information that some unknown person/persons have stored sands illegally at Beldih village. Accordingly the fact is noted in GDE vide Arsha PS GDE No. 912 dt. 25/09/21 and myself along with force left PS for Beldih village for holding raid. At about 09.25 hrs myself along with force reached at Beldih village and found that at an open place (Just beside the Beldih village "moram" road and back side of the house of Dhananjoy Gorai S/O- Amulya Gorai of village Beldih, PS- Arsha) approx 700 cft sand stocked by unknown person/persons illegally. During enquiry nobody did not say the name of the person who stocked the sand illegally.

I seized the sand which amounting to approx 700 cft after prepared proper seizure list and handed over through zimmanama to Kajal Gorain S/O Manbodh Gorain of Rath Tola, Station-road Purulia, PS- Purulia (T), Dist- Purulia for further proceedings. After observing all formalities I returned to PS.


Therefore, I pray a specific case may kindly be started and arrange for investigation.
