Sub: - Complaint lodged against Offence u/s 21(1) of The Mines and Minerals (Development and Regulation) Act, 1957; Rule 3 of the WB Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2002; Rule 50 of the West Bengal Minerals Minor Minerals Concession Rule 2016.

A tractor (blue color) bearing chassis no. T053419200HG carrying 100cft (approx) of sand has been intercepted by the undersigned on 27.09.2021 around 12:05p.m. at Nimtal (Baghmundi-Balarampur Road), P.S.-Baghmundi, Dist.-Purulia. The driver of the said vehicle failed to produce any lawful authority or valid transit pass to carry such mineral, the driver tried to flee along with the said vehicle. Thus the Driver/Owner of the vehicle has violated the provisions of Section 4(1)/4(1A) of the Mines and Minerals (Development and Regulation) Act, 1957, and liable to be prosecuted with imprisonment for a term which may extend upto 2yrs or Rs. One lakh fine or both, in accordance with Sec.21(1) of the Mines and Minerals (Development and Regulation) Act, 1957, Rule 3 of the WB Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2002; Rule 50 of the WB Minor Minerals Concession Rule 2016 and also under Section 379/411 of the Indian Penal Code.

The said seized vehicle along with 100cft of sand has been brought to PS and handed over to your custody.

Therefore, you are requested to initiate a specific case against the offended in terms of law. This should be treated as FIR.
