Sub: Complaint regarding the bike rally playing with sound box without permission against some persons of "প্রকৃতি বাঁচাও ও আদিবাসী বাঁচাও মঞ্চ", অযোধ্যা পাহাড়, বাগমুন্ডি during Covid-19 pandemic situation at Ajodhya Hill area under Baghmundi PS.

With due respect, on 27.09.2021 while I SI Banshi Badan Mondal of Baghmundi PS along with force 1. C/778 Sanjoy Chowdhury, 2. C/765 Lalmohan Murmu both of SAP 11th Bn. under Baghmundi PS, Dist-Purulia were performing special mobile duty at Ajodhya Hill area vide Baghmundi PS GDE No- 1247, Dated- 27.09.2021 & C.C. No- 2774/21, dtd- 16.09.2021. During my special mobile duty on getting credible information at about 10:30 hrs that some Adibasi peoples of Ajodhya Hill area and outside are assembled with bike and sound system fitted vehicle near APUS at Chhatni to conduct a awareness rally at some villages of Ajodhya Hill area. When myself along with force reached near APUS at Chhatni in between 10:55 hrs and found some Adibasi leaders of "প্রকৃতি বাঁচাও ও আদিবাসী বাঁচাও মঞ্চ" namely 1.Supen Hembram of Vill-Bhursabera, 2.Shyamsundar Mandi of Simulbera, 3.Gulan Ch. Murmu of Kalijharna, 4.Kedar Sing Mura of Ajodhya, 5. Nakul Baskey of Chhatni all under Baghmundi PS, 6.Rajen Tudu of Panchet, PS-Neturia, 7.Sashi Kanta Murmu, (Professor of Lalpur Collage) of Kashipur and some unknown persons were unlawfully assembled for Bike Rally with tablo vehicle fitted with sound system. They were asked to produce any valid permission regarding the said bike rally by playing sound system but they failed to do so. Then I asked them to not do this bike rally as this is not permitted by local administration during Covid-19 pandemic situation. But they did not pay heed my words and they were started bike rally by playing sound system in high volume. They have been covered many Adibasi village roads of Ajodhya Panchayet area upto 19:45 hrs at Teliabhasa village without any valid permission and disobeying Covid-19 protocols.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No-753/IX-ISS/2M-22/2020, dtd- 15.09.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence those persons are refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request and violated the order by conducting bike rally by playing sound system.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
