




Fact of the case

The complainant

Most respectfully begs to state :-

1...That the complainant is the legally married wife of the accused No. 1. MajnU Ansari. The marriage in between the complainant the accused No. 1 was solemnized on 10.3.2017 as per rites, custom and formalities of Islam religion of of Muslim caste.

2... That at the time of marriage the father of the complainant had to give cash Rs. 71,000/- and value of Motor Cycle Rs. 75,000/- and other uten sil, furniture, Almira etc. As per demand of the accused No. 1 and 2 moreover her father also had to give ornaments to the complainant.

Mejnu Ansari as husband and wife in the joint mess with mother—in—law, Nanad and others but after three months of the marriage the accused No. 1,2 and 3 demanged motor cycle from the complaint of her father about the demand of her matrimonial home, her father could not full fil the demand of her in laws members as a result of which, the accused No. 1 to 3 changed their behaviour upon the complainant and they used to torture, mentally and physicall y by abusing rebuking and insulting and by assaulting but the complainant was there bearing althose tourtures with hope that matter will be normalised after somedays. Fortunately a female child has been born out the wed lock of complainant and the accused No. 1.

5... That the accused No. 4 used to visit at the matrimonial home of the complainant and they used to instigate provoke the accd. No. 1,2 and 3 to couse torture upon the complainant by saying unless motor cycle is given to us by the petitioners father. The torture will be continued.

6...That 2.9.2021 the all accd. persons after assaulting the complainant and the snatching all belongings ornaments drove out the complainant. From their house and the complainant seeing no other alternative came to her father's house with her minor daughter. And since then the complainant has been residing at her father's house.

7... That the above matter was informed to the I.C. Balaram pur P.S. with a prayer to take legal action against the accd. persons. But till date no action yet been taken. Hence this complainant

It is therefore prayed that your Honour would be pleased to take legal action against the accd. persons.
