Sir,

With due respect I humbly inform you that I am Sanjoy Gosai S/o - Paban chandra Gosai, a Permanent Resident of vill-Deoli, PO-NEKRE, P.S- Balarampur Purulia.

On the dated- 19/09/2021 - at about 7:30-8:30 P.M - a group of men attacked on me - at Deoli upper-para - near- Sri Sri Thakur Anukul chandra mandir when I came back towards my home after chanting the holy prayer. Then I started running to escape and save my valuable life. When I took shelter in a bush at Sri Kisiti Kumar's House - back side, they find me with help of torch and pitted me on my different important body-parts. Instantly I fainted. After 45 seconds I got up - still they were present there and also kicked me and threw bricks and stones.

From there they pulled me with rope and to become faultless they informed my father the whole matter falsely. The persons are following -

- ① Maliram Paramanik -  
(Job - cook of D.H.S. - he pitted me with rod and bebaboo (stick with help of others))
- ② Khirad Paramanik (Real Name - Abodh Paramanik)  
S/o - Late - Manik Paramanik
- ③ Prabodh Paramanik - S/o - Late Manik Paramanik
- ④ Biswajit " S/o - Maliram Paramanik
- ⑤ Satish " S/o - Maliram "
- ⑥ Anash " S/o - Prabodh "
- ⑦ Himanshu " S/o - Khirad "

All the villagers were the witness of that incident.

So, my earnest request to you to lodge a complain against them and give me the best service of Police.
