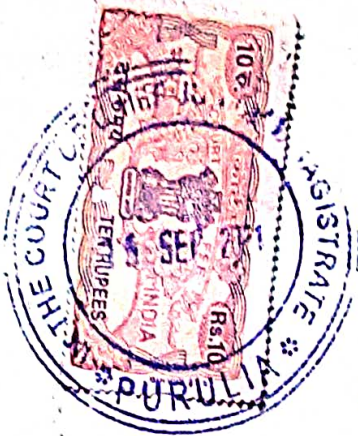

The Complainant – Petitioner most respectfully begs to state as follows –

1. That the above named Complainant – Petitioner is the legally married wife of the Accused No. 1 paternal house of the Complainant – Petitioner is at Village and P. O. Genrue under Balarampur Police Station in the District of Purulia and matrimonial home of the Petitioner – Complainant is at Village and P. O. Haragara under Joypur Police Station in the District of Purulia and offences committed at Village Haragara under Joypur Police Station in the District of Purulia and at Village Genrue under Balarampur Police Station in the District of Purulia and both within the Jurisdiction of this Ld. Court.
2. That the Complainant – Petitioner begs to state that the paternal house of the Complainant – Petitioner is at village and P. O. Genrue under Balarampur Police Station in the District of Purulia and the Complainant – Petitioner 10 years before got married with the Accused Arjun Gope a resident of Village and P. O. Haragara

under Joypur Police Station in the District of Purulia as per Hindu law and rites and customs prevalent at their community. At the time of marriage the Accused No. 1 took Rs. 50,000/- cash from the father of the Complainant – Petitioner as Dowry and as per demand of the Accused Persons father of the Complainant – Petitioner gave gold ornaments of two *bhari* (bangle and ear ring) and utensils. After marriage the Accused No. 1 took the Complainant – Petitioner at his house at Village Haragara under Joypur Police Station in the District of Purulia and both the Accused No. 1 and Complainant – Petitioner started to reside there under same roof as husband and wife. After three four months of marriage the Accused No. 1 every night started to return home in drunken condition and started to assault the Complainant – Petitioner without any cause. As father of the Complainant – Petitioner is economically very weak thus the Complainant – Petitioner inspite of such assault and torture remained mum and tolerated the same with the expectation that in future the Accused No. 1 will stop such torture and lead happy conjugal life. In course of such conjugal life the Complainant – Petitioner blessed with two sons. The Accused No. 1 also started to abuse the sons in filthy languages. Two years ago the Accused No. 1 demanded Rs. 3,00,000/- from the Complainant – Petitioner for purchasing Tractor and trolley and asked the Complainant – Petitioner to collect that amount of money from her father. As the Complainant – Petitioner asked the Accused No. 1 inability of her father to pay that amount due to his weak financial condition, hence the Accused No. 1 as well as Accused No. 2 started to assault the Complainant – Petitioner by slaps as well as started to abuse her in filthy languages alleging that until and unless the father of the Complainant – Petitioner shall pay the said amount of Rs. 3,00,000/- to the Accused No. 1 said torture will continue. In spite of such torture the Complainant – Petitioner remained at her matrimonial home. But months before while father of the

Complainant – Petitioner went to the matrimonial home of the Complainant – Petitioner to meet her, then the Accused No. 1 gave out to the Complainant – Petitioner that ask your father when he will pay the said amount of Rs. 3,00,000/-. Hearing such words of the Accused No. 1 the father of the Complainant – Petitioner asked the Accused persons that he is financially very weak and it is not possible for him to pay such huge amount. Hearing the reply of the father of the Complainant – Petitioner the Accused Persons became furious and abused the Complainant – Petitioner and her father in filthy languages and by assaulting turned them out from their house. In such circumstances the Complainant – Petitioner along with her father and sons spend night at Joypur Railway Station and next day came to Village Genrua under Balarampur Police Station in the District of Purulia. The Complainant – Petitioner submits that thereafter on 10th day of August 2021 the Accused No. 1 in the noon all on a sudden came to the paternal house of Complainant – Petitioner at village Genrua and asked the Complainant – Petitioner what she decided about the demand of Rs. 3,00,000/- of the Accused No. 1, the Complainant – Petitioner answered that it is not possible for her father to pay such amount and hearing the answer of the Complainant – Petitioner the Accused No. 1 became furious and started to assault the Complainant – Petitioner. In such circumstance the father of the Complainant – Petitioner came and noticing the father of the Complainant – Petitioner the Accused No. 1 started to assault the father of the Complainant – Petitioner and abused in filthy languages and said to the Complainant – Petitioner that forget to lead conjugal life and returned giving out that if he noticed the Complainant – Petitioner or father of the Complainant – Petitioner at his village he will murder them.

3. That the Complainant – Petitioner thereafter on 11. 08. 2021 went to Balarampur Police Station to lodge Complaint against the

accused persons but police said by such Complaint she will not benefited and refused to receive the same. Hence the Complainant - Petitioner on 16 - 08 - 2021 filed the Written Complaint before Superintendent of Police, District Purulia but till date no step taken from the end of Police. Hence this Application.

It is therefore prayed that your honour may graciously be pleased to take cognizance of the Offences, complained in this Petition committed by the Accused persons and send the same to Officer in Charge, Balarampur Police Station, District Purulia for investigation and necessary action.
