Sir, S. Smt. Tapati Das, B.M., BGB Barabazar Branch want to lodge FIR against Sri Dayamoy Tripathy, S/o-Atreya Tripathy of village Rampur, P.O. Barabhum, Dist - Purulia for his aggressive and violent attack on two officials (on duty) near Ragma village.

On 17/09/2021, Sri Prasenjit Choudhury, Manager BGB Barabazar and Sri Dipak Mahato, A.M. of Barabazar branch conducted a field visit to Ragma, Rampur and Bansbora village for recovery of NPA loans which are due to the bank for a long period. As a course of official duty our officers visited to the house of Dayamoy Tripathy at Rampur but he was not at home. During their return near Ragma at around 12.30 PM. Sri Dayamoy Tripathy came in a cycle and violently rushed towards the officers. He stopped them in the middle of main road and continuously uttered slang languages towards our officers. He tried to assault Sri Choudhury and threatened to Sri Choudhury that he will make a loss of life of Sri Choudhury. He already took all the whereabouts of Sri Choudhury at Barabazar.

Sir This has caused a lot of mental pressure, agony and fear in the mind of our officials particularly to Sri Choudhury as he is from Bankura town and have to reside at Barabazar to perform his official duty.
