Sub: Prayer for lodged FIR.

Sir,

In producing herewith one Dumper bearing Registration No- OD 19D 0048 loaded with approx 700 c.ft Stone Cheli, seizure lists & seized article.

I beg to state that on 22.09.2021 myself along with C/- 1182 Santosh Mahato and C/- 1474 Tushar Kanti Mandal, C.D/- 957 Pradip Sinha Mahapatra (Govt Driver) were performing evening mobile duty vide Barabazar PS GDE No- 1121 Dtd 22.09.2021 with Govt vehicle bearing Registration No- WB 26K 5475. When we are going towards Taladih village on Latpoda to Dhargram pitch road and reached near Taladih morh under Barabazar PS at about 18.35 hrs found one vehicle coming from Taladih side towards Barabazar and seen the Police party after standing the Dumper beside the pitch road on Latpoda to Dhargram pitch road near Taladih morh, under Barabazar PS the driver fled away. Myself along with force rushed to the spot and found one Dumper bearing Registration No- OD 19D 0048 loaded with approx 700 c.ft Stone Cheli standing beside the pitch road. We searched for the driver/ owner of the Dumper but none turned up.

I conveyed the same to I.C Barabazar PS. Over mobile phone and Seized the Dumper bearing Registration No- OD 19D 0048 loaded with approx 700 c.ft Stone Cheli under proper seizure list duly signed by witness. The seizure was done in between 18.55 hrs and 19.25 hrs.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the Dumper collected the stone by illegal means with intent to make unlawful profit by unlawful collection of stone through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said Dumper with ill motive were transporting the stone illegally without any valid document in support of carrying the stone. They violated the Govt. order of not extracting stone. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said Dumper.
