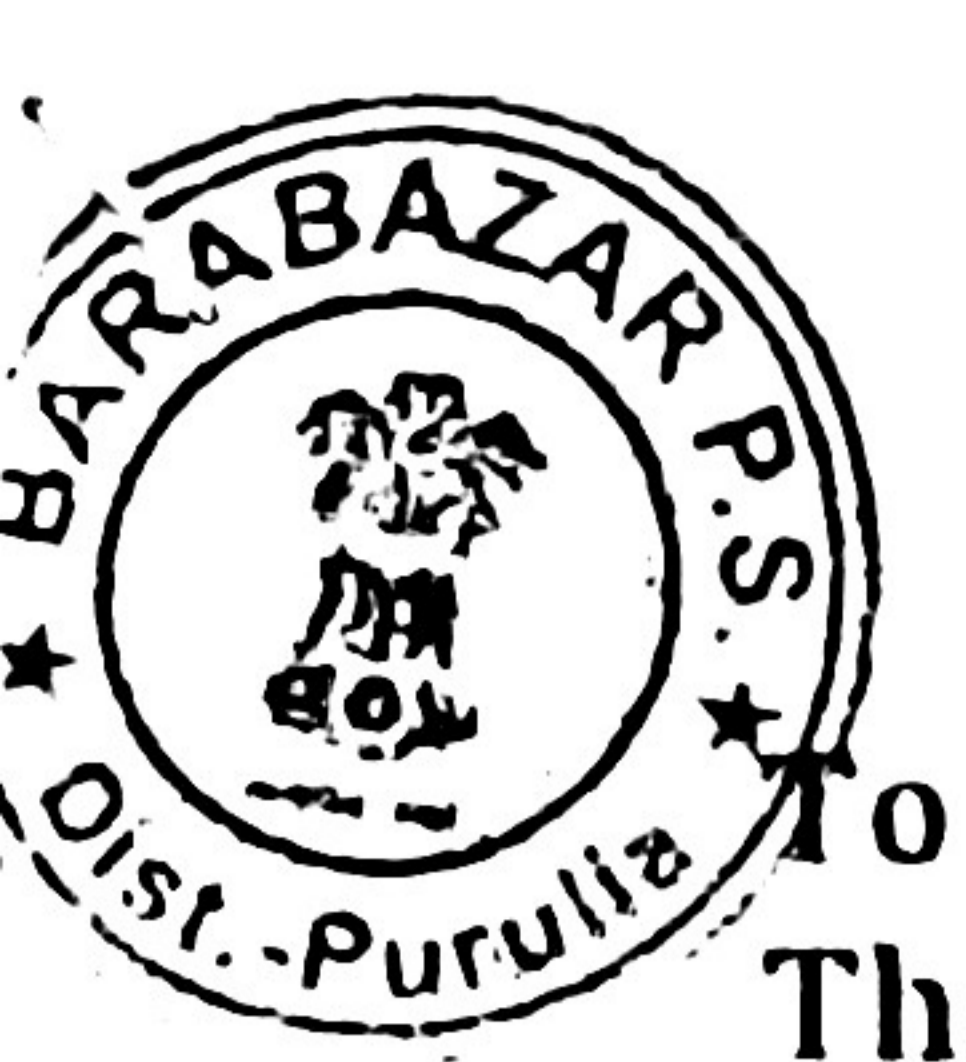

Sub: Prayer for lodged FIR.

Sir,

In producing herewith one tractor attached with trolley, bearing Registration No- WB 55A 4668 loaded with approx 100 c.f.t sand, seizure lists, seized article.

I beg to state that on 07.09.2021 myself along with C/- 1182 Samar Kumar Maiti and C/- 111 Samulal Tudu were performing special raid mobile duty vide Barabazar PS GDE No- 346 Dtd. 07.09.2021 with Govt vehicle bearing Registration No- WB 26K 5475. When we are going towards Sindri on Barabazar Sindri road and reached near Chirkundi morh under Barabazar PS at about 20.35 hrs found one tractor coming from Manbazar, Sindri side towards Barabazar and seen the Police party after standing the tractor beside the pitch road on Barabazar - Sindri near Chirkundi morh, under Barabazar PS the driver fled away. Myself along with force rushed to the spot and found one tractor attached with trolley bearing Registration No- WB 55A 4668 loaded with (approx) 100 c.f.t sand and standing beside the pitch road. We searched driver/ owner of the tractor but none turned up.

I conveyed the same to I.C Barabazar PS. Over mobile phone and Seized the tractor attached with trolley loaded with sand about 100 c.f.t approx bearing Reg No- WB 55A 4668 under proper seizure list duly signed by witness. The seizure was done in between 21.05 hrs and 21.25 hrs.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the Tractor collected the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mine & minerals. As such there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. order of not extracting sand from the river. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said tractor.
