Sub: Prayer for Lodged FIR

Sir,

In producing here with one (vehicle) Dumper having registration No- JH 05AJ 5371, loaded with large pieces of stone about 500 CFT and I beg to state that on 07.09.2021 myself along with C/- 357 Gopal Biswas and C/- 2703 Sanjib Mahanty were performing special raid mobile duty vide Barabazar PS GDE No- 346 Dtd. 07.09.2021 with hire vehicle bearing Registration No- WB 56N 4133. I was carrying normal investigation kit box with me.

During Spl. mobile duty at Sarberia morh at about 19.15 hrs received source information about extracting and transportation of stone with intend to sale to other destinations by illegal means from Taladih side towards Barabazar under this PS jurisdiction.

I conveyed the same to I.C Barabazar and as per his direction I along with force started Naka checking at Sarberia morh from 19.25 hrs. At about 19.45 hrs one (vehicle) Dumper having registration No- JH 05AJ 5371 loaded with stone was coming toward the Naka point and seeing the police party the driver fled away after keeping the vehicle beside the road at Sarberia village. Chased him but somehow he managed to escape. I waited reasonable time and but none came and produce any valid document or paper in respect of loaded stone. Accordingly, I seized the (vehicle) Dumper having registration No- JH 05AJ 5371 loaded with large pieces of stone about 500 CFT with proper seizure list. The seizure was done in between 20.15 hrs & 20.35 hrs.

Held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner collected the stone by illegal means with intend to make unlawful profit by unlawful collection of stone by illegal manner through unauthorized extraction and removal of mines & minerals. By this way they committed theft of minerals.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of (vehicle) Dumper having registration No- JH 05AJ 5371.
