# The above name complainant begs to state as follows:

That the complainant is a very poor cultivator and somehow earns his livelihood. The property which is situated at mouza Puriyara, under P.S. Barabazar recorded as khatian no. 156, R.S. Plot no. 1829, is his ancestral property and they are possessing the same in various ways including by planting so many trees thereupon and accordingly the complainant along with his co-sharers are possessing those trees having their valid title. On the other hand the above noted accused persons have no manner of right or possession over the land as well as the standing trees.

It is very pertinent to point out that the complainant party have won one Title Appeal bearing no. 50/2012 wherein their right and possession have been confirm, contrary to that the above noted accused persons have lost the case.








That on the date of incident i.e. on 19/07/2021 corresponding to 2<sup>nd</sup> Sraban 1428 B.S. the above note accused persons armed with axe, lathi, tangi, etc criminally trespassed in to the land of the complainant and the accused persons have illegally and wrongfully have cut two trees and taken away, the value of those trees would be Rs. 15.000/- approximately. When the complainant protested the accused persons theft and then the miscreants abused the complainant party in filthy languages and assaulted them.

- That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- 4) That the matter was reported to the Officer-in-charge Barabazar P.S. against the accused persons but the said Officer-in-charge did not taken any legal action after passage of considerable time, then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant is under







compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.
