As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.
