Sir,

In producing here with arrested accused namely Bijoy Tudu (36 Yrs) S/O- Lt. Budhu Tudu of Vill- Majhidih (Daldali), PS- Hura, Dist- Purulia along with seized one white colour plastic container containing approx 10 (ten) ltrs. ID liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 16.09.2021 at 18:15 hrs. received a credible source information from my reliable source that the above noted accd. person was stoking and selling Id liquor at Majhidih (Daldali) village. Accordingly I informed the matter to O/C Hura PS and as per his direction I SI Jayanta Chakraborty along with force vide Hura PS C.C. No.- 2538/21 date- 16.09.021 left for work out that information. After reaching to spot along with force and held raid in between (18:45 hrs. & 19:45 hrs) in the house of above noted accused person at Majhidih (daldali) under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling ID liquor which was kept in his house at Majhidih (Daldali) under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking ID liquor. Accordingly, I seized one white colour plastic container containing approx 10 (ten) ltrs.
