In producing here with one Dibakar Mahato (39) S/o Biswanath Mahato of Uhupiri, PS-Jhalda, Dist-Purulia after arrest with one seized Tractor having Registration Number WB55A/8225 attached with Trolley loaded with approx 100 CFT of sand.

The fact of the case in brief is that today (05/09/2021) I ASI Ramnath Gorai, C/2957 Tapas Das, C/2976 Rabi Dutta & C/ 2203 Siba Prasad Bera all of Tulin OP under Jhalda PS were performing anticrime evening mobile duty at Tulin OP area. At about 20:05 hrs when we reached at Magha Bridge on Magha Darpa road found one tractor attached with trolley loaded with sand was coming from Magha side. On suspicious basis I gave signal to stop the said vehicle. On seeing my signal driver of the said tractor immediately stopped the vehicle and we managed to apprehend the driver of the above noted Tractor. On asking he gave his name and address as Dibakar Mahato (39) S/o Biswanath Mahato of Uhupiri, PS-Jhalda, Dist-Purulia. On demand he failed to produce any paper in respect of loaded sand as well as of the tractor and also made incoherent statement in respect of loaded sand. On return to Jhalda P.S., I produced the arrested driver namely Dibakar Mahato (39) S/o Biswanath Mahato of Uhupiri, PS-Jhalda, Dist-Purulia along with seized Tractor having Registration Number WB55A/8225 attached with Trolley loaded approx with 100 cft. sand at Jhalda PS compound and I do here by submitting written complaint before you to start a cog case against the above noted driver of the above noted tractor and against it's registered owner under proper section of law.
