PS-Kotshila. Dist-Purulia 3. Sachinath Mahato (22) S/O Shyama Charan Mahato of Vill- Dulmi, PS-Jhalda. Dist-Purulia 4. Lakshinarayan Goswami (36) S/O Lt. The fact of the case in a nut shell is that I. LSI Anima Adhikary along with force namely (i) C/66-Joydeb Das (ii) C 1496-Subal Ch. Mahato (iii) HG 1636-Harekrishna Ghosh were performing the raid duty against the night lock down at New PS more under Halda PS. Subsequently I along with force arrived at spot on 10 09 2021 at 23 05 hrs. for the implementation of the Govt Order regarding the night restriction. This refers to Jhalda PS GDE No 431 dtd 10 09 2021 in consonance with C C No 3526/21 Dtd 10 09 2021. During the riaka duty at New PS more. I intercepted the above noted 07 (Seven) persons noted in the supra (SI no 1-07), who were fortering aimlessly without wearing the maskand not maintaining the social distance. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted lottering after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and discheved the direction during this pandemic situation duly promulgated by Govt of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753 II-JSS/2M-22/20 dtd 28/06/21 and Memo No 753/III-155/2M-22/2020 dtd 14/07/21 and Memo No-753/IN-155/2M-22/2021 dtd-29/07/2021 Thereafter in addition to the order of Govt. Of West Bengal for all outdoor activities from 23.00 hrs to 05.00 hrs vide order No- -753/V-ISS/2M-22/2020 dated-13/08/2021 Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt, of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/2020 dtd 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd 28.06.21 and Memo No-753/III-ISS/2M-22/2021 dtd-29/07/2021 Thereafter in addition to the order of Govt, Of West Bengal for all outdoor activities from 23:00 hrs to 05:00 hrs vide order No-753/V-ISS/2M-22/2020 dated-13/08/2021 Ergo, they can be booked U/S 188 of the IPC and 51 (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act. 1897 Ergo a specific case may kindly be initiated against them and arranged for its investigation.
