Entered the premises of JAGADISH MAJHI , S/o- LT. MANSU MAJHI, resident at DIGARDIH, PS- JHALDA, Dist-
PURULIA having consumer Id- 242228382, Meter no DDG440288 and inspected his/ her premises. During the
inspection theft of electricity was detected i.e. by bypass the energy meter i.e. U/S 135(I)/(B) was detected. The
details of bypass arrangement were *broken the seal and use illegal electricity by means of meter bypass and hence*
using electricity in his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 05 nos.
2. Electric Fan - 03 no.
3. Color TV- 01 no.
4. Refrigerator- 01 nos.

Out of which I seized the following.

1. One no electric bulb.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the
premises at 01.10 P.M on 07.09.2021. The accused person has committed an offence U/S 135(I)/(b) of the
electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance of
