Sir,

I, Smt. Arpana Das, wife of Swapnil Kumar Das, a Commando, a resident of Village Jargo, P.S. Jhalda, at present residing at my Father's house at Village + P.S. Bansra, P.S. Korda, lodge this diary against my husband (1) Swapnil Kumar Das, Son of Late Purna Chandra Das and my brother-in-law (2) Sanjoy Das and his wife (3) Smt. Saraswati Das of Village Jargo, P.S. Jhalda, (4) Kailash Das, Son of my husband's uncle and his wife (5) Smt. Suchitra Das and their daughter (6) Tapasi Das(Putul), of Village Korua, Balurampur and my husband's Dethima (7) Srimatya Belarani Das widow of Late Kishori Mohan Das of Adra and my Da(8) Smt. Bebi Das, wife of Sudaj Kumar Das of Adra and (9) Smt. Sulaksha Das, wife of Basanta Das of Ranchi and (10) Smt. Sikha Das, wife of Bhulanath Das of Sanduan who are my husband's elder sisters on the following facts :-

1. That my marriage with Swapnil Kumar Das was held on 16.06.2020 as per rites and customs prevalent in our Society. In the said marriage my father gave sufficient Cash and kinds including golden ornaments, wrist watch and other costly articles. After marriage I went to my husband's house, but since after marriage I was subjected to torture both physically and mentally at the hands of the above persons. My husband and other persons used to torture me on the plea that insufficient dowry was given in the said marriage and they demanded Re.3,00,000/- (Rupees three lakhs) from my Father. However my Father

for the purpose of restoring peace in the family gave Rs.50,000/- to my husband as he demanded that he will run a grocery business. But however as per their demand was sky kissing so they used to assault me and sufficient food and clothing was not given to me. In every night my husband in a drunken condition came to my bed and assaulted me and even he used to place burning Siri on my hands. Other accused persons also joined to commit such offences. My husband has illicit relation with Tapasi Das(Putul). So my husband off and on used to go to Kaxua and stayed with her.

2. That as I objected, so my husband mercilessly assaulted me. My husband's sister Sulekha and Sikha abused me with filthy language over mobile phone and advised my husband not to keep and maintain me.

3. That on 17.04.2021 due to torture I fell sick and on the following date i.e. on 18.04.2021 my husband with the help of a two wheeler kept me in my father's house and hurriedly left and since then I have been staying at my father's house at Village Bansa. My husband did not spent a single furthing towards my treatment and even he did not enquire about my whereabouts.

4. That on 27.08.2021 my father, my mother, my Pisamasai Ghaisiram Das took me to my husband's house at Village Jargo. But I found that the house is under lock and key. After informing the Panchayet member we returned back to village Bansa. Due to torture I fell sick and
