In producing herewith one arrested accused person namely Saktidhar Mahto @ Fatik (39) S'o Puran Mahato of Vill.- Kocho, PO-Putki-Noyadih, PS-Silli, Dist.- Ranchi, Jharkhand under arrest along with seized articles as per seizer list i.e. 20 (Twenty) pieces of plastic bottles Country Sprit having 600 ML in each bottles and 07 (Seven) pieces of plastic bottles Country Sprit having 300 ML in each bottles printed as "Dil Khush" on the outer side of the bottles in a big size plastic bag under proper seizure with label.

1 SI Jayanta Kumar Chakraborty of Tulin OP under Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on 15/09/2021 at about 21:15 hrs I received a credible source information (This ref. to Tulin OP GDE No. 443 dated 15/09/2021) that the above noted accused person was selling country sprit illegally at Maru more under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/3159 Subesh Singh, C/3008 Kartik Duley all of Tulin OP under Jhalda PS left to work out the information (This refers to Tulin OP under Jhalda PS CC No. 1269 dated 15/09/2021 and GDE No. 444 dated 15/09/2021). At 21:35 hrs we reached at Maru more and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country sprit "Dil Khush" bottles were kept there in concealing condition. On searched total 27 (twenty seven) pieces of country sprit "Dil Khush" bottles were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that that he is usually selling the same to the villagers / pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 22:15 hrs to 22:45 hrs in which 02 (two) bottles of "Dil Khush" i.e. one 600 ML and another 300 ML were kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 22:55 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Saktidhar Mahto @ Fatik (39) S/o Puran Mahato of Vill.- Kocho, PO-Putki-Noyadih, PS-Silli, Dist.- Ranchi, Jharkhand u/s-46A (c) of the Bengal Excise Act 1909.
