In producing herewith one arrested accused person namely Janu Mahato (61) S/o Late Baneswar Mahato of Vill.- Choupad, PO-Tulin, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. approx 09 (Nine) liters of illicitly distilled liquor (Cholai) in a plastic jeriken under proper seizure with label.

I SI Jayanta Kumar Chakraborty of Tulin OP under Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on 23/09/2021 at about 21:25 hrs I received a credible source information (This ref. to Tulin OP GDE No. 684 dated 23/09/2021) that the above noted accused person was selling illicitly distilled liquor (Cholai) illegally at Choupad village more on Magha-Darpada Road under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/3159 Subesh Singh, C/2770 Sanjoy Dey both of Tulin OP under Jhalda PS left to work out the information (This refers to Tulin OP under Jhalda PS CC No. 1317 dated 23/09/2021 and GDE No. 685 dated 23/09/2021). At 21:45 hrs we reached at Choupad village more and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of illicitly distilled liquor (Cholai) were kept there in concealing condition. On searched total approx 09 (Nine) liters of illicitly distilled liquor (Cholai) were found there in a jeriken. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers / pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 22:25 hrs to 22:45 hrs in which 01 (one) 100 ML bottle of "illicitly distilled liquor (Cholai)" was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 22:55 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Janu Mahato (61) S/o Late Baneswar Mahato of Vill.- Choupad, PO-Tulin, PS-Jhalda, Dist.- Purulia u/s-46A (c) of the Bengal Excise Act 1909.
