In producing herewith one arrested accused person namely Shankar Bagdi (47) S/O Lt. Bharat Bagdi of Vill.- Kansra, PO-Mosina, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. 04 (Four) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" and 30 (Thirty) pieces of plastic bottles Country Sprit having 300 ML in each bottles printed as "Dil Khush" on the outer side of the bottles in a plastic bag under proper seizure with label.

I PSI Habibur Rahman of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (24/09/2021) myself along with C/696-Gorapada Pal, TC/66-Jaydeb Das, NVF/778-Samir Ch. Mahato, HG/1681-Manmatha Kumar all of Jhalda PS were performing anti crime special mobile duty (This refers to Jhalda PS CC No. 3913 dated 24/09/2021 and GDE No. 1034 dated (24/09/2021). During special mobile duty at about 18:15 hrs I received a credible source information that the above noted accused person was selling country sprit illegally at Kansra village in his grocery shop under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force proceeded to work out the information. At 18:45 hrs we reached at Kansra village and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country sprit "Dil Khush" bottles were kept there in concealing condition. On searched total 34 (Thirty four) pieces of country sprit "Dil Khush" bottles were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 19:25 hrs to 20:05 hrs in which 02 (two) bottles of "Dil Khush" i.e. one 600 ML and another 300 ML were kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 20:15 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Shankar Bagdi (47) S/O Lt. Bharat Bagdi of Vill.- Kansra, PO-Mosina, PS-Jhalda, Dist.- Purulia U/S-46A (c) of the Bengal Excise Act 1909,
