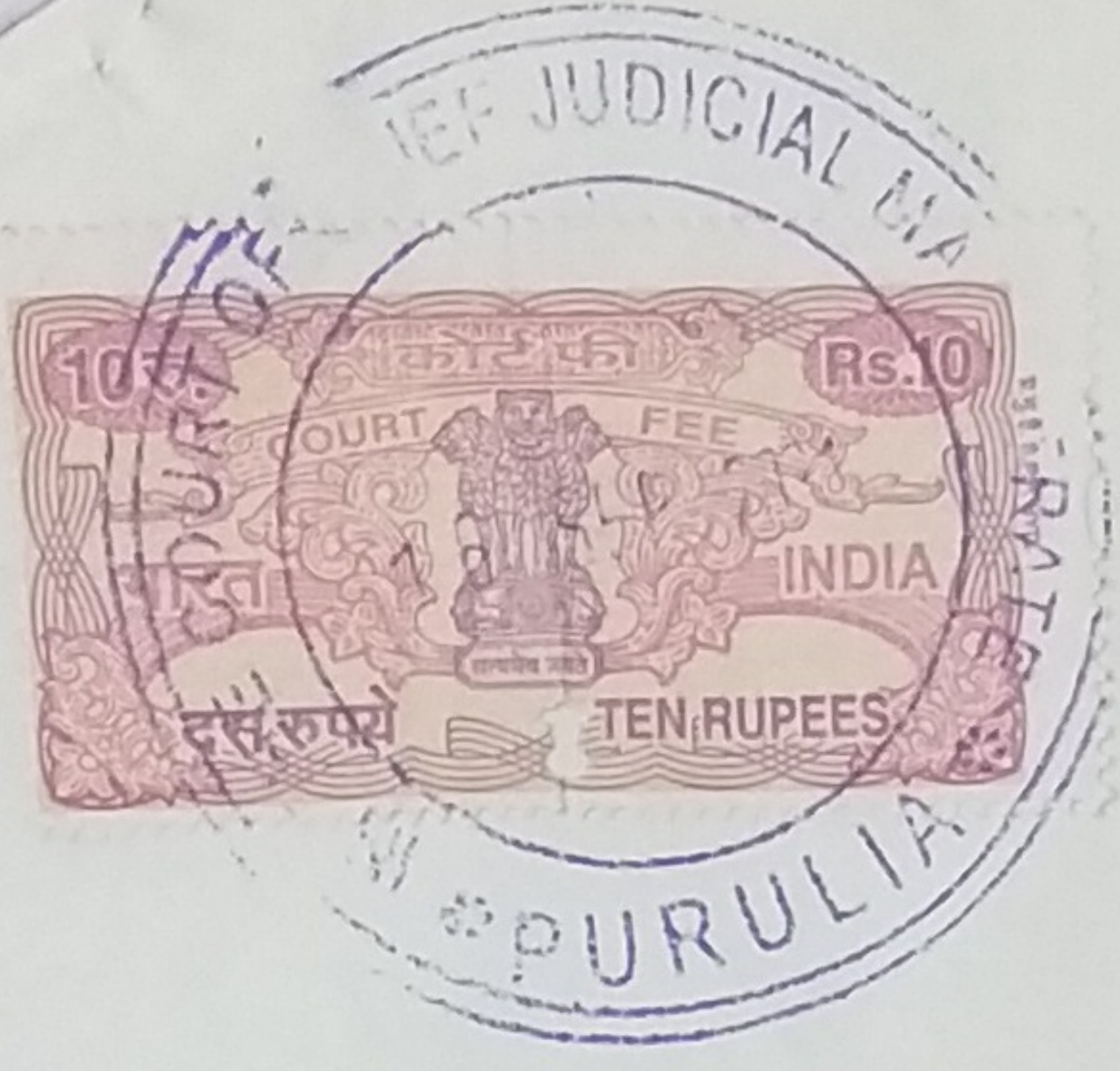

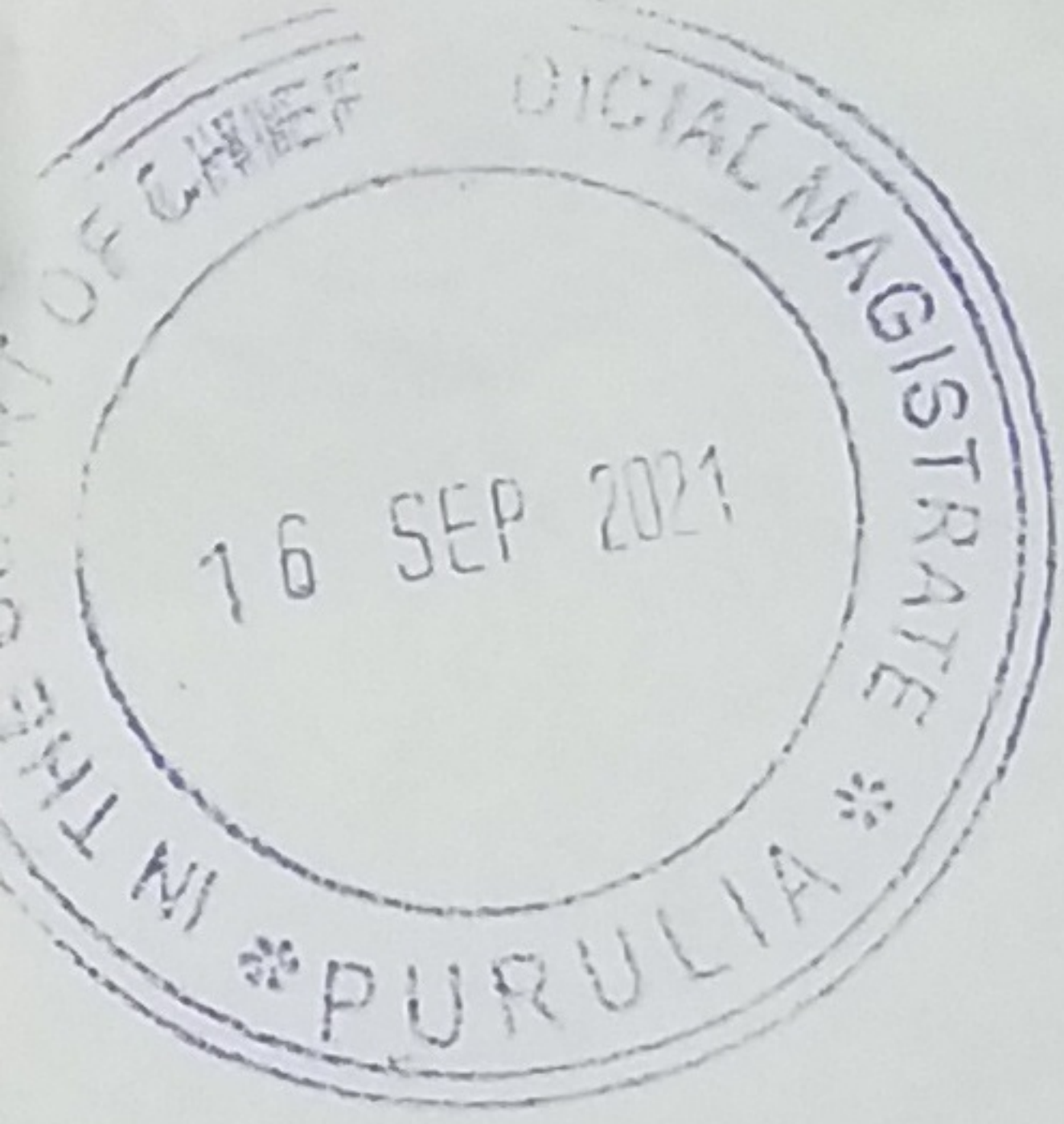

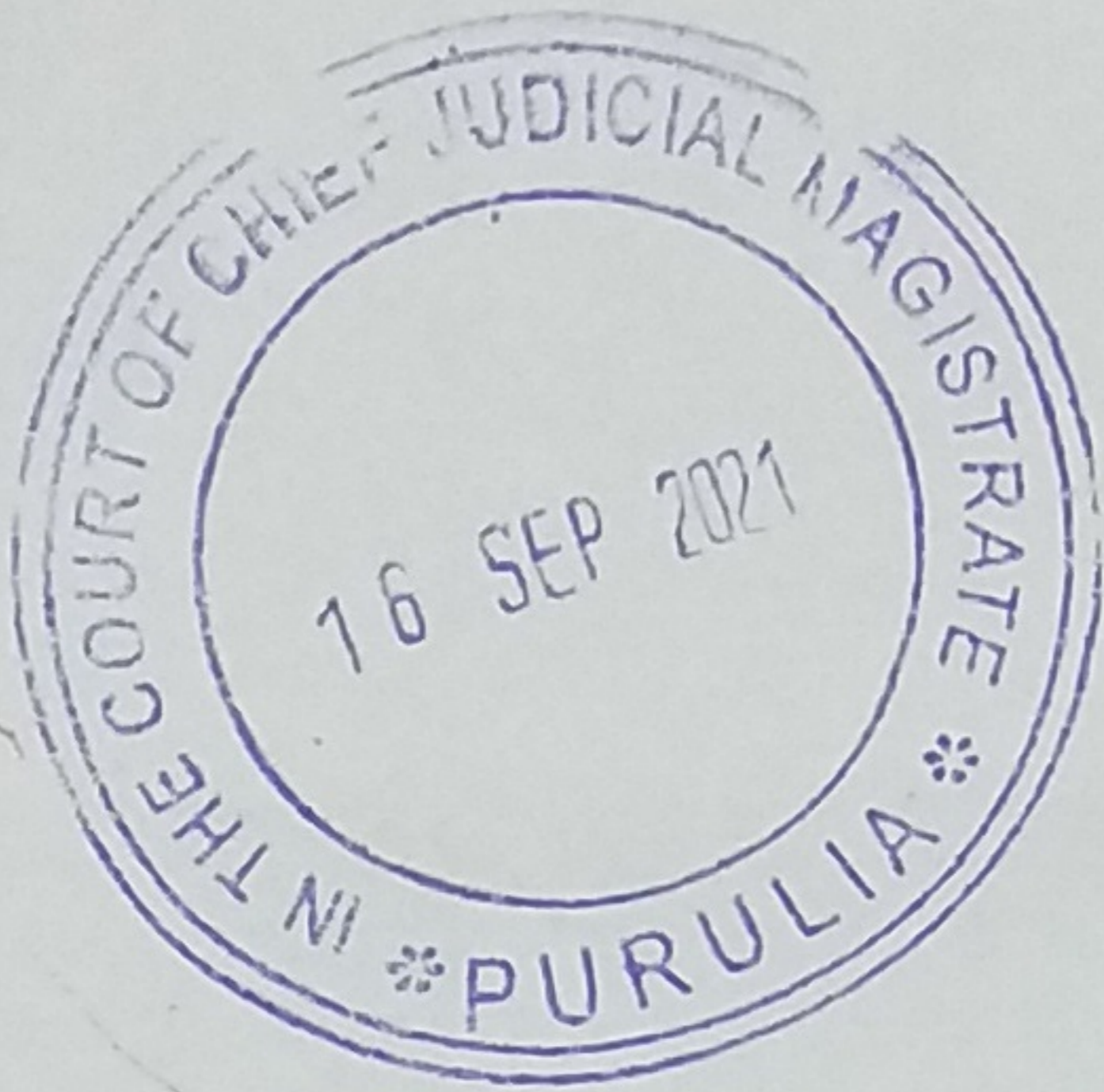
- 2) That, the Complainant raised boundary wall by mud and also planted some trees near the boundary wall of the Complainant such as Nim, Jam, Mango, guava, etc. and enjoying the same, but on 15.07.2021 the accused person along with the help of J.C.B. Vehicle and driven by the Accused No. 2 demolished the boundary wall of the Complainant, and also trespass the trees by J.C.B. vehicle which planted by the Complainant, at that time family members of the Complainant informed to the complainant that one J.C.B.
