Sir,

In producing herewith 01 (one) arrested accused person Santosh Kewat (26 yrs) S/o-Amrit Kewat of Vill-Jeladih PS-Joypur Dist-Purulia under arrest along with seized articles as per seizer list i.e. 18 (Eighteen) bottle Country Spirit "DIL. Se" under proper seizure with label.

I SI Dipankar Biswas of Baglata IC under Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (16/09/2021) at about 10.25 hrs when myself along with JC1436 Ahammar Ansary & NVF/901 Shibeswar Kuiry were performing anticrime special raid duty vide Joypur PS CC No-1585/21 Date-16/09/2021, as per my source information I reached at Jeliyadih village under Joypur PS and found that the above noted accused person selling Country Spirit ("DIL. Se") in the shop of Santosh Kewat. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 18 (Eighteen) bottle Country Spirit which was kept in his shop in a bag. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Country Spirit to the local people in the villagers. On demand he failed to produce any valid documents in respect of selling such Country Spirit. So it is reasonable to believe that he was selling the ld liquor illegally without any documents. So I seized the same under proper seizure list on 16/09/2021 in between 10:35 hrs to 10:55 hrs & label duly signed by him and other available witness after taking 600 ML. as sample in one bottle.

During further interrogation he confessed his guilt as such I arrested him today 16/09/2021 at 11:05 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Santosh Kewat (26 yrs) S/o-Amir Kewat of Vill-Jeliyadih PS-Joypur Dist-Purulia. U/S-46A (c) of the Bengal Excise Act 1909.
