Sir,

In producing herewith one arrested accused person namely Stalin Das (42 y) S/o-Bhim Das of Vill-Narayanpur, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 14 (Fourteen) bottles illicit country spirit "DIL KUSH" strength 80 up measuring 600 ML each bottles out of which one bottle taken as sample under proper seizure with label.

I SI Dibakar Kuiri of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (16/09/2021) at about 10:25 hrs when myself along with C/-2087 Debasih Gorai, NVF/-018 Biswanath Mahato were performed special mobile duty vide Joypur PS C.C. No-3204 Date-16/09/2021, as per my source information I reached at Narayanpur village under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" at his house. On seeing Police persons, he conceal his presence at that house, but on searching we able to trace out him and also to found that 14 (Fourteen) bottles of illicit country spirit "DIL KHUSH" which was kept conceal in a bag in his house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling illicit country spirit liquor to the local people in Narayanpur village after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 13:15 hrs to 13:30 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 13 bottles of DIL KHUSH. During further interrogation he confessed his guilt as such I arrested him today 16/09/2021 at 13:35 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Stalin Das (42 y) S/o-Bhim Das of Vill-Narayanpur, PS-Joypur, Dist-Purulia, State-WB, U/S-46A (c) of the Bengal Excise Act 1909.
