Fact of the Case:

- 1) That on 01.08.2021 at about 07:00 P.M. the Accused Person namely Ranjit Kumar Mahato and some anti social persons along with a tractor vehicle entering into the Complainant's land and cultivated the complainant's land and also change nature and character and demolished the ail of the khet.
