Sir,

In producing herewith one arrested accused person namely Thakurdas Paramanik (42 yrs) S/o-Late Khedan Paramanik of Vill-Palanja, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 14 (Fourteen) bottles Illicit country spirit "DIL KUSH" strength 80 up measuring 600 ML each bottles out of which one bottle taken as sample under proper seizure with label.

I ASI Swapan Mandal of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (24/09/2021) at about 18:05 hrs when myself along with C/-516 Chandra Shekhar Mahtao UC/-2087 Debasish Ghorai were performed special mobile duty vide Joypur PS C.C. No-3329 Date-24/09/2021, as per my source information I reached at Forest More near Palanja Rail gate under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" at his shop. On seeing Police persons, he conceal his presence at that shop, but on searching we able to trace out him and also to found that 14 (Fourteen) bottles of Illicit country spirit "DIL KHUSH" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in Palanja village after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country spirit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 18:35 hrs to 18:45 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 13 bottles of DIL KHUSH. During further interrogation he confessed his guilt as such I arrested him today 24/09/2021 at 18:50 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Thakurdas Paramanik (42 yrs) S/o-late Khedan Paramanik of Vill-Palanja, PS-Joypur, Dist-Purulia, State-WB, U/S-46A (c) of the Bengal Excise Act 1909.
