Respected Sir,

In producing herewith arrested accused Ram Saren (40 years), S/O Kalpana Saren of vill - Gamarkuri, Namopara, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 24.09.2021 at 18.25 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Gamarkuri village in his house. Accordingly I, PSI Gourango Roy along with C/2280 Akinchan Mandal and NVF/693 Jayanta Sing Sardar reached at Gamarkuri village in his house of the above noted accused at 18.55 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) One white colour jarikin loaded with approx 10 (Ten) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a separate container as sample with sealed and labeled and (2) 05(Five) pieces of Plastic glass. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 19.25 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Ram Saren (40 years), S/O Kalpana Saren of vill - Gamarkuri, Namopara, PS - Kashipur, Dist - Purulia and arrange for its investigation.
