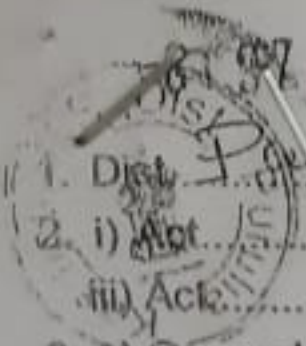

Sub: prayer for lodge FIR against the unknown owner of the vehicle no WB55B3133.

This is to intimate you that today i.e on 10.09.2021 at about 6am on information a raid is conducted by the spatial task force formed by the honorable District Magistrate Purulia and BI&Iro office kashipur. During the raid program a tractor bearing no WB55B3133 was found carrying earth illegally on paharpur road .Driver of the tractor has left the tractor and escaped immediately.
