This is to intimate you that Today i.e. on 11.09.2021 at about 07 AM on information a raid has been conducted by the special task force formed by the Honorable District Magistrate Purulia along with the undersign and Revenue Officer and others staff of BL&LRO office Kashipur. At the bank of Darakeswar River ,Raghunathpur Mouza, Plot No 969,970,997,998, illegal stored sand are identified by Subimal Mandal S/O Late Biswanath Mondal of Village- Sonajuri, PS\_ Kashipur, Dist- Purulia, Amin during the raid. It has been found that approx 500cft. Sand illegally stored in the above said land. Team of BL&LRO, Kashipur has been seized the illegal stock at 7am to 8 am. Said sand has been sent to nearest lessee on the basis of the "Zimmanama" to the Bapi Gorai S/O Khetra Pal Gorai Village- Lohapara, PS- Kashipur, Dist- Purulia. And I also collected & seized 10KG Sand as a Sample from the stock pile of sand. The Seizure list, as well as the said "zimmanama" and Sample stock pile of sand are being attached with this letter in original for your concern.




