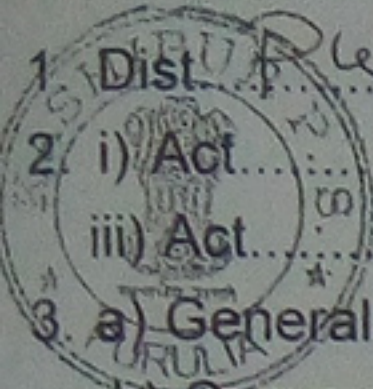

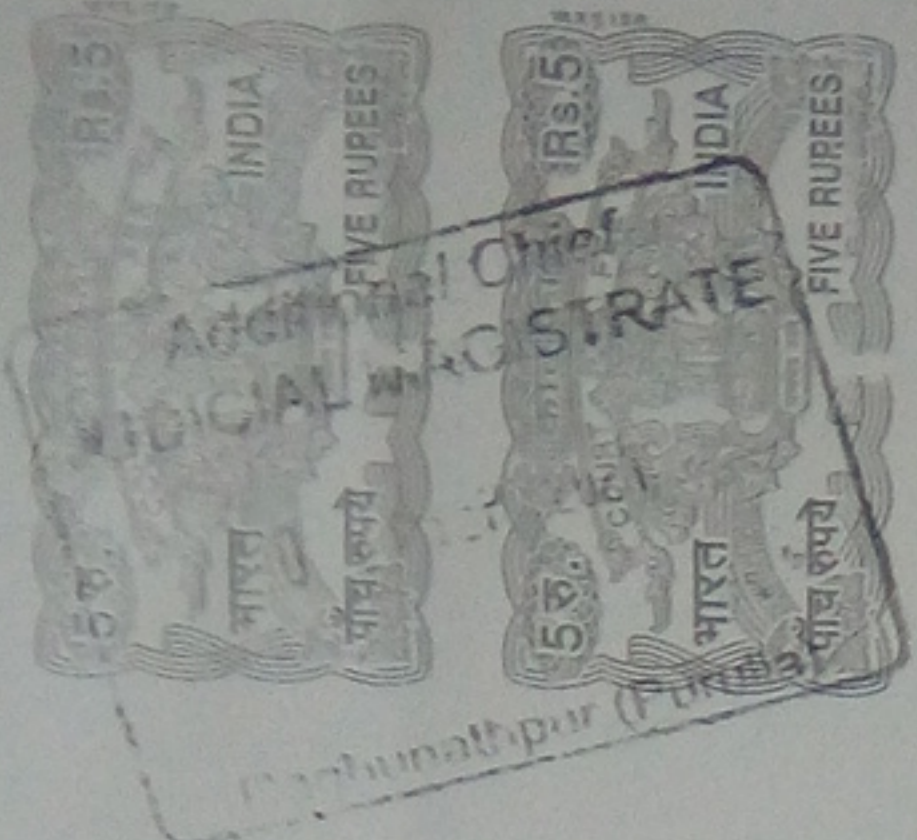

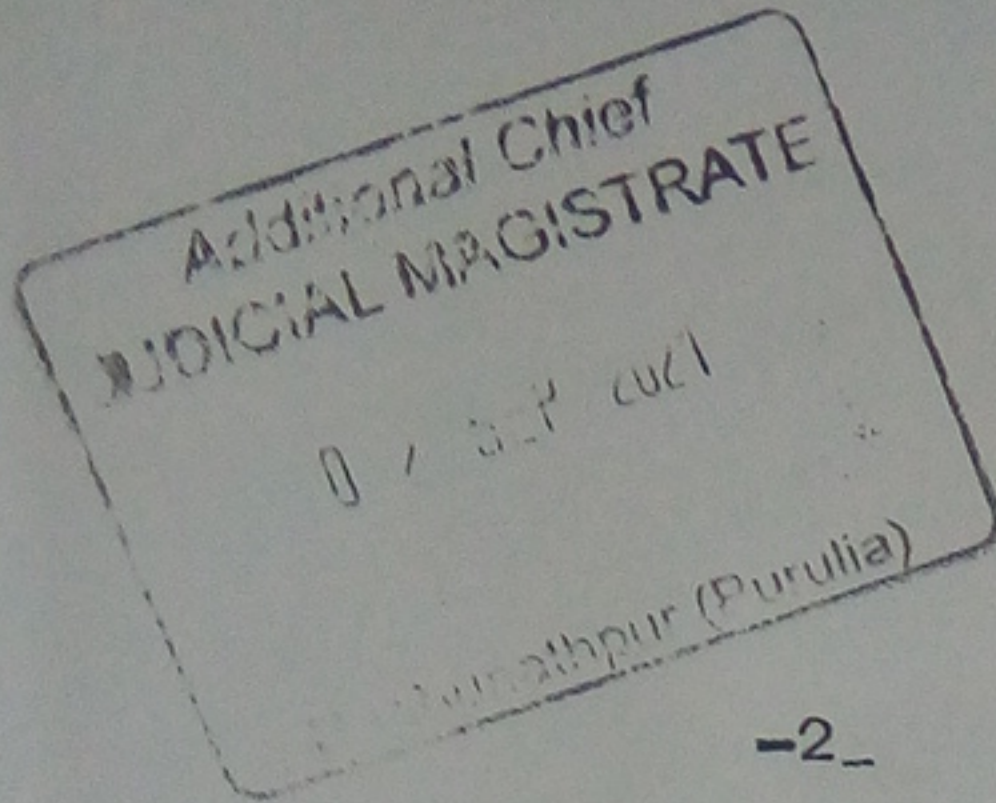

Kashipur, Dist: Purulia, since so many decades of year.

2. That the complainant and his father and brothers ploughed that sch. 1 land with tractor and planted green crops with a hope of food grains in future but on 10-08-2021 at about 4 P.M. when they had been to their land, saw the accd. persons namely, -i) Gour Bauri S/O Lt. Naran Bauri, ii) Uttam Bauri S/O Gour Bauri, iii) Apu Bauri S/O Gour Bauri of their village criminally trespassed into their land armed with Axe (Kural), Iron rod and shabal to destroy the planted crops.

3. That accd. persons tried to attack the complainant and his brother with the Axe, shabal and iron rod to injure them but somehow complainant and his brothers managed to save their person from the attack of the accd. persons.

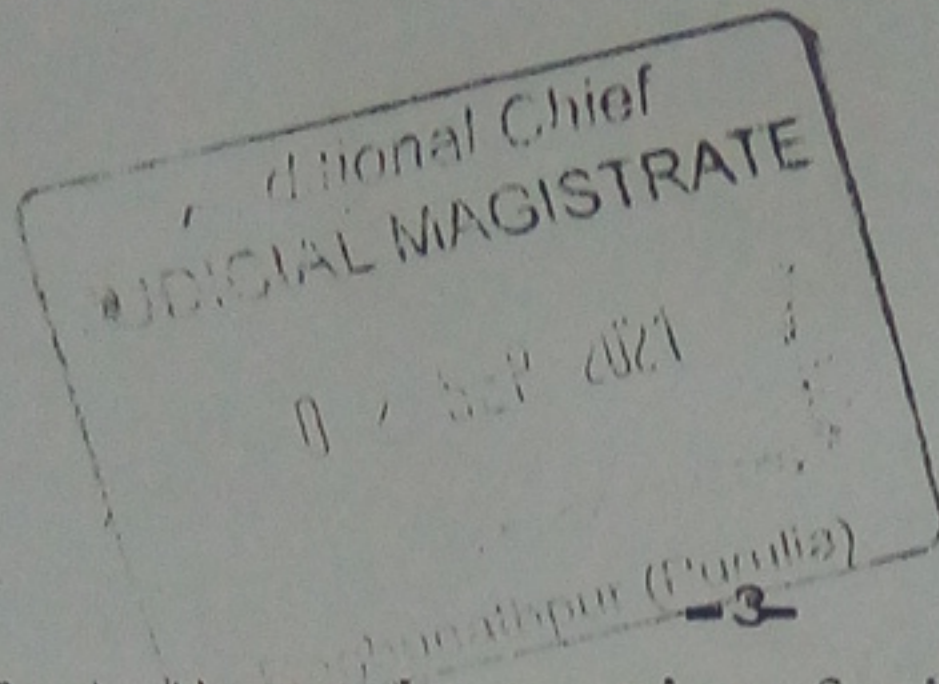
4. That the accd. persons destroyed maximum green crops which the complainant planted with a cost of RS:-2000/- for ploughing the land and RS:-1500/- was the cost of seeds of crops. The accd. persons also threatened them with dire consequences and cautioned them not to enter or plough into their own land.

5. That after that incident the complainant and his family members very much frightened and made a written complaint before the Kashipur P.S. on 11-08-21 but O/C Kashipur did not lodge any F.I.R. in this matter as such the complaint sent to Kashipur P.S. by Regd. post.

6. That as the Kashipur P.S. took no steps in that matter the complainant also sent a copy of complaint to S.P. Purulia on 13-08-2021 with a hope to lodge F.I.R. in this matter but till now no F.I.R. lodged by Kashipur P.S. in this matter and offenders are threatening the complainant regularly.



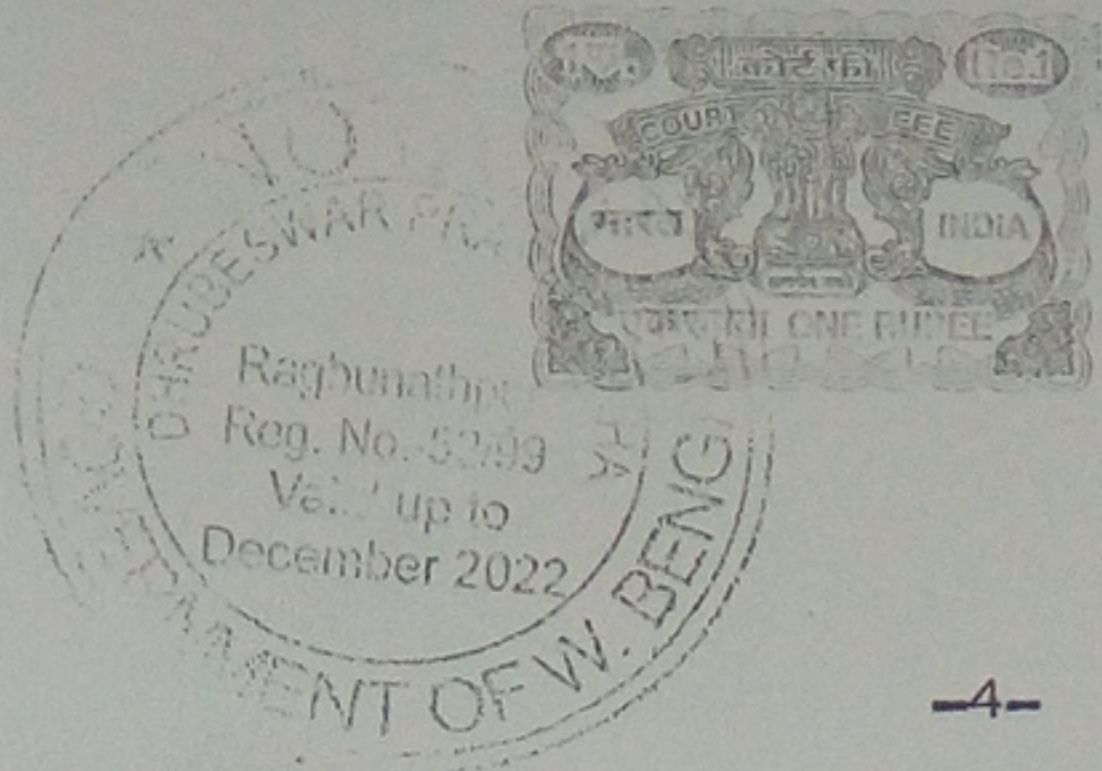

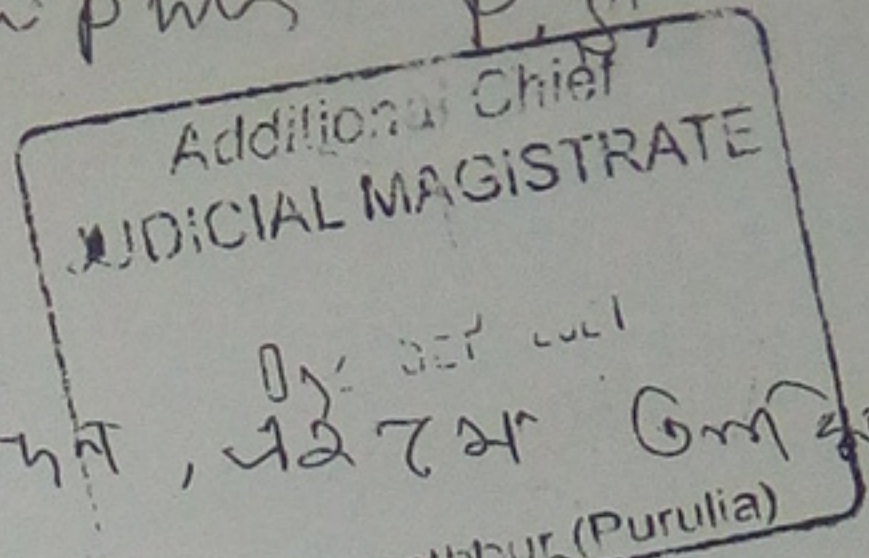
