Respected Sir,

In producing herewith one arrested accd. person namely Lab Bouri (35 years), S/O Lt Arun Bouri of vill – Napara, PS - Kashipur, Dist – Purulia along with seized articles viz. 1) 19( Nineteen) bottles (each 300 ML) of country spirit printed value Rs-25/- each and 2) One white colour jarikin loaded with 05(Five) liters ID liquor (Chullu) .

I SI Pratap Ch. Ojha would like to draw your kind attention to the following facts that today i.e. 16.09.2021 myself along with 1) C/1191 Subodh Hansda and 2) NVF/0041 Paltulal Mahato were engaged in evening mobile duty at PS area vide Kashipur PS CC No- 2256/21 dtd- 16.09.21. In course of evening patrolling duty at about 18.25 hrs received a Telephone information from reliable source that one Lab Bauri of Napara is selling I.D liquor at his residential house at Napara under PS- Kashipur. On receiving this information I along with force left for the above noted spot. Reached at the spot at about 18.30 hrs and we searched the house in presence of the accd. as noted above and disinterested local people and found the aforesaid liquor kept in his house. He could not give any satisfactory answer regarding the above said liquor and stated that he kept these articles for selling. On my demand he failed to produce legal license for stocking and selling the liquor. Accordingly I seized 1) 19 (Nineteen) Bottle CS liquor brand as "Dil Khush" 300 ML each out of this 19 bottles 01 bottle took as sample with sealed and labeled (2) One white colour jarican loaded with 05(Five) liters ID liquor (Chullu) after proper labeling duly signed by the accused and police witnesses (no public witnesses turned up to sign) under proper seizure list and provide one copy of seizure list to him and arrested said accused person namely Lab Bouri (35 years), S/O Lt Arun Bouri of vill – Napara, PS - Kashipur, Dist – Purulia on 16.09.21 at 19.05 hrs after maintaining legal formalities for illegal stoking and selling of liquor illegally as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Lab Bouri (35 years), S/O Lt Arun Bouri of vill – Napara, PS - Kashipur, Dist - Purulia and arrange for its investigation.
