Sir,

In producing herewith the accused namely Durga Charan Mahato (32 Yrs.), S/o- Laxman Mahato of Vill- Tentlo, PS- Barabazar, Dist- Purulia and also seized vehicles (Tractors) bearing Registration No. WB55B-3072, Chassis No. MBNABAEXKLNK01013 & Engine No. NLK2EAE0019 attached with Trolley loaded with sand without any number plate. The fact of the case in brief is that on 02/09/2021 I along with C/2644 Mithun Duley and NVF/239 Rabindra Nath Mahato of Kenda PS were on night mobile duty. During mobile duty on 03/09/2021 at about 01.25 hrs. when we reached near at Kesya Morh found that the above noted tractor was coming from Damda side under Kenda PS. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor near at Kesya More but we manage to detain the driver of the said tractor. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor. We searched the said tractor and found that the tractor was loaded with sand. We waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Reg. No. WB 55B-3072 attached with Trolley loaded with sand without any number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said tractor after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arrange to inform his relatives. Thereafter arranging driver from my source and brought the tractor at Kenda PS. So it reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the Tractor having Registration No. WB 55B-3072 attached with Trolley loaded with sand without number plate.
