Sub: Request for lodging FIR against arrested accused person.

Respected Sir,

I, PSI SK Rahaman of Kenda PS, Dist- Purulia in producing herewith one arrested accused person namely Jibon Hansda (60 Yrs), S/o – Lt. Sarkar Hansda of Vill- Rajakhanda (Majhidih) , P.S – Kenda, Dist- Purulia with seized articles i.e. 1) One white colour jarican containing Approx 18 Ltrs. ID Liquor 2) 08 pcs plastic glasses (3) Approx 180 ml ID liquor as sample which was collected from seized articles in Sl No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (16-09-2021) during special raid duty acting on a secret source information myself along with (1) C/181 Rabban Sekh, (2) C/2519 Arun Duley of Kenda PS conducted raid in the residential house of accused person namely Jibon Hansda at about 17:15 hrs and found that he was keeping and selling of ID liquor to the others at his residential house at Rajakhanda (Majhidih). Seeing the Police party, all customers fled way but we managed to apprehend the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing Approx 18 Ltrs. ID liquor 2) 08 pcs plastic glasses (3) Approx 180 ml ID liquor as sample which was collected from seized articles in Sl. No-01 & kept in a bottle under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about the ground of arrest and place of detention.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Jibon Hansda (60 yrs), S/o – Lt. Sarkar Hansda of Vill- Rajakhanda (Majhidih) , P.S – Kenda, Dist- Purulia as per proper section of law.
