In producing herewith one arrested person namely Md. Subhan Khan @ Quraishi (22 Y) S/O- Md. Iqbal Quraishi of Gudri Chalk, Lower Bazar, P.S- Lower Bazar, Dist- Ranchi, Jharkhand with one four wheeler styled as black colour SCORPIO STD having Reg. No- WB 02Y 5768. I ASI Subash Kaibartya beg to state that today on 05.09.2021 at 20:05 hrs while I along with 1) C/982 Shyamal Rajwar, 2) C/557 Ambuj Mandal were engaged in Naka checking duty at Tali Center More under Kotshila PS. During naka we were trying to stop to check one Scorpio coming from Jhalda side to Purulia side on Purulia-Ranchi road on SH4A in which three (03) persons were boarded and after noticing Police from near away they stopped Scorpio and tried to fled and after short chase we could apprehend one of them but the other two managed to fled away from that place. On asking he disclosed his indentify as Md. Subhan Khan @ Quraishi (22 Y) S/O- Md. Iqbal Quraishi of Gudri Chalk, Lower Bazar, P.S- Lower Bazar, Dist- Ranchi, Jharkhand and stated that he is going to Kolkata. After apprehending I also asked him to produce valid papers in respect of above noted Scorpio having Reg No- WB 02Y 5768 but he could not produce any valid papers against the said four wheeler and could not provide any satisfactory reply. On further interrogation he confessed that they have stolen that Scorpio and name of the rider was Kuddus Ansary. Further he also revealed that he and Anash Ansary S/O- Md. Muksud Quraishi of Gudri Chalk, near Karbala Chowk, P.S- Lower Bazar, Dist- Ranchi, Jharkhand are going to sell that.

Accordingly I seized the said four wheeler styled as SCORPIO STD, Black Colour having Reg No- WB 02Y 5768 after preparing proper seizure list duly signed by witnesses and local people refused the sign in seizure list.

In accordance with the law and adhering all guidelines regarding arrest, I arrested the accused Md. Subhan Khan @ Quraishi (22 Y) S/O- Md. Iqbal Quraishi of Gudri Chalk, Lower Bazar, P.S- Lower Bazar, Dist- Ranchi, Jharkhand.

Therefore I pray that a specific case may kindly be registered against the above noted accd. persons i.e arrested accd. 1) Md. Subhan Khan @ Quraishi (22 Y) S/O- Md. Iqbal Quraishi of Gudri Chalk, Lower Bazar, P.S- Lower Bazar, Dist- Ranchi, Jharkhand 2) Anas Ansary S/O- Md. Muksud Quraishi of Gudri Chalk, near Karbala Chowk, P.S- Lower Bazar, Dist- Ranchi, Jharkhand and rider of the vehicle Kuddus Ansary under proper section of law.
