Sir,

In producing herewith one seized vehicle i.e Tractor Mahindra B 275D1 (Red Colour), without Reg. Number, & having Engine No- NKAZEMJ0127 and Chassis No- MBNABAEXPJKJA04217, fitted with Trolley (without number plate) loaded with sand. The fact of the case in brief is that on 21/09/21 I, A.S.I Subash Ch. Kaibartya of Kotshila P.S along with force were on day mobile duty on Kotshila- Purulia road. During mobile duty on 21/09/21 at about 13:05 hrs received credible source information that the above noted (Tractor) is coming from Joypur side loaded with sand. After receiving this information we were proceeding towards "Jabragora more" under Kotshila P.S. When we reached near "Jabragora more" under Kotshila P.S, found that the above noted (Tractor) was coming from Joypur side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance at Jabragora more and tried to unload the sand loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near "Jabragora more" at 13:25 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the Tractor Mahindra B 275D1 (Red Colour), without Reg. Number, & having Engine No- NKAZEMJ0127 and Chassis No- MBNABAEXPJKJA04217, fitted with Trolley (without number plate) loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Kotshila P.S. As such there is every reason to believe that the driver and owner of the Tractor Mahindra B 275D1 (Red Colour), without Reg. Number, & having Engine No- NKAZEMJ0127 and Chassis No- MBNABAEXPJKJA04217, fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra B 275D1 (Red Colour), without Reg. Number, & having Engine No- NKAZEMJ0127 and Chassis No- MBNABAEXPJKJA04217, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
