Sir,

In producing here with one accused person Subal Singh Sardar (50) S/O Lt. Banku Singh Sardar of village Sindurpur, PO- Jitujuri PS Manbazar, District Purulia along with following seized articles viz-

- (1) 18 (Eighteen) Ltrs ID liquor within a Jarikan
- (2) 12 pieces plastic glass
- (3) Sale proceed of Rs- 125/-

I SI Mahadeb Rana of Manbazar PS do here by lodged a complaint against accused namely Subal Singh Sardar (50) S/O Lt. Banku Singh Sardar of village Sindurpur, PO- Jitujuri PS Manbazar, District Purulia to the effect that today (16.09.2021) at 16:45 hrs. I received a telephonic information from a reliable source that one Subal Singh Sardar (50) S/O Lt. Banku Singh Sardar of village Sindurpur, PO- Jitujuri PS Manbazar, District Purulia has stocked ID liquor illegally and selling the same after hike price for his personal gain. I noted this information in GDE vide Manbazar PS GDE No- 1054 Dtd 16.09.2021. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with ASI Anirban Banerjee C/531 Shib Sarkar Mahanty, HG/1443 Uttam Kr Singh rushed to the spot for conducting raid by Govt. vehicle. At about 17:25 hrs myself along with force reached at Sindurpur village more and held raid of Subal Singh Sardar and found that said person selling ID liquor. Seeing the Police party some persons fled away and said Subal Singh Sardar tried to concealed himself but he was able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Subal Singh Sardar (50) S/O Lt. Banku Singh Sardar of village Sindurpur, PO- Jitujuri PS Manbazar, District Purulia as per law and arrange for its investigation.
