**The above name complainant begs to state as follows:**

- 1) That the complainant inherited a piece of land situated at mouza Pathar Mohara under P.S. Manbazar recorded as Khatian no. 15, plot no. 347, and 347/1029 area 68 decimals which was actually purchased by the father of the complainant namely Lalmohan Ghatak through registered deed bearing no. 3478 for the year 1965 and accordingly the complainant has right and possession over the same and have kept paddy seed ling in a part. On the other hand the above noted accused persons have no manner of right or possession over the land in question.
- 2) That on 31/07/2021 corresponding to 14<sup>th</sup> Sraban 1428 B.S. at about 11:00 am while the complainant was transplanting paddy in the above mentioned land, at that time the above

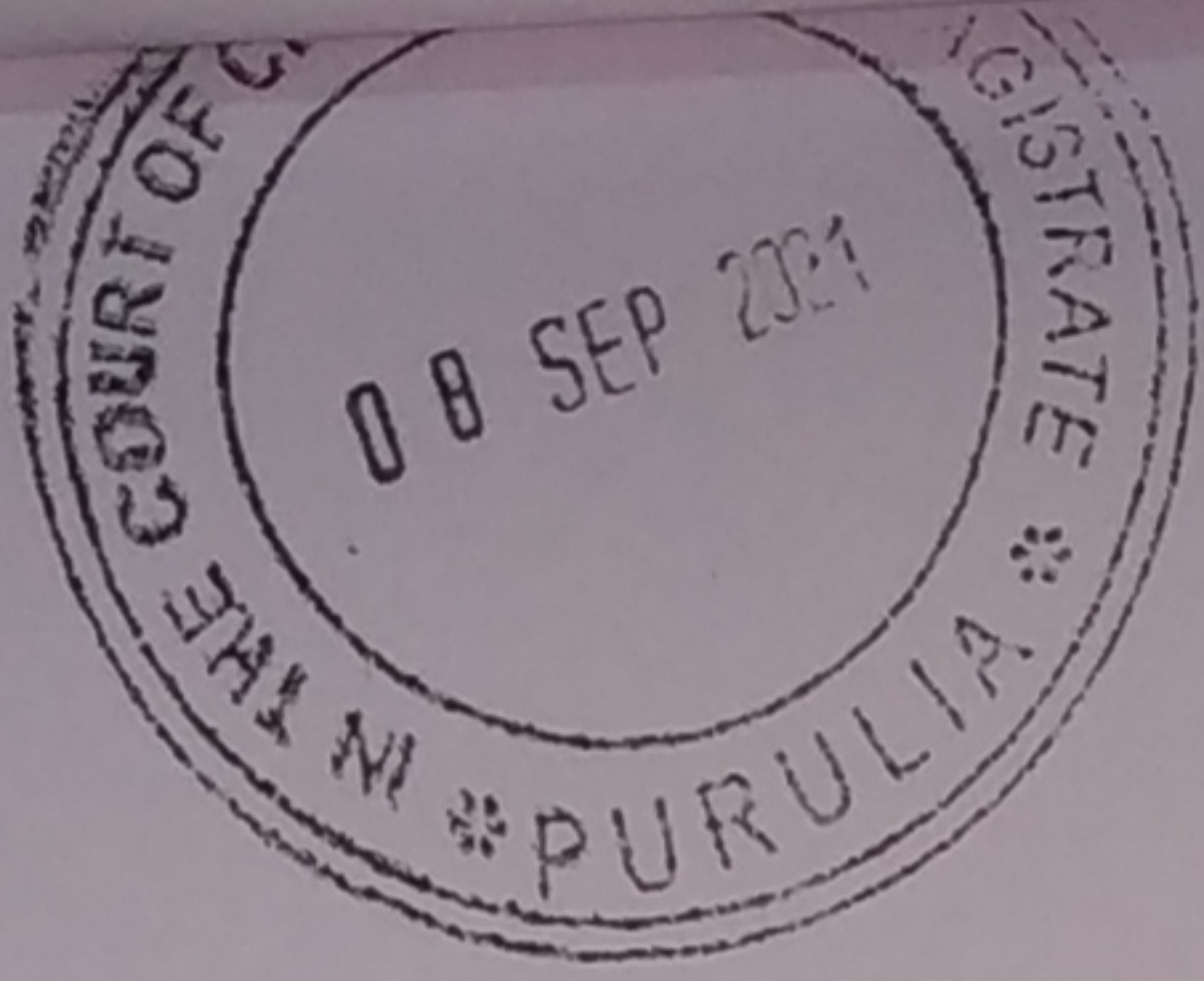

noted accused persons armed with lathi, tangi iron rod etc criminally trespassed in to the land of the complainant and abused him in filthy languages. When the complainant protested then the accused persons assaulted the complainant mercilessly by felling him on the math. For which the complainant sustained injuries on his person. Thereafter, the accused persons also damaged all those paddy seed lings by plowing paddy seed lings with the help of tractor bearing registration no. WB55A 0624 drive the tractor by one Chiran Bauri causing loss of Rs. 10,000/- In the manner stated hereinabove the above noted accused persons done such illegal incident and they also still threatening the complainant in various ways for which the complainant is in a panic stricken condition.

- 3) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- 4) That the matter was reported to the Officer-in-charge Manbazar P.S. against the accused persons but the said Officer-in-charge did not taken any legal action after
