Sir,

In producing here with 05 (five) arrested persons namely (1) Kartik Sing Sardar(29), S/O- Rabi Sing Sardar of vill-Ramnagar, PS- Puncha, Dist- Purulia (2) Sangram Mandal(33), S/O- Dhirendranath Mandal of vill-Sargo, PS- Barabazar, Dist- Purulia (3) Sultan Ansary(28), S/O- Jalil Ansary of vill-Bankata, PS-Manbazar, Dist- Purulia (4) Balaram Bauri (55), S/O- Gangadhar Bauri of vill-Laharia, PS-Puncha, Dist-Purulia (5) Bikram Mandal(21), S/O- Dhananjoy Mandal of vill- Bardaha, PS-Barabazar, Dist- Purulia with Memo of arrest & other relevant papers.

I beg to state that today (16/09/2021) I was engaged in mobile duty at Dalaha more with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 686 Dtd- 16/09/2021. Accordingly when I was performing duty at Dalaha more. I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the accd people. The whole process was done in between 17.05 hrs to 17.55 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Kartik Sing Sardar(29), S/O- Rabi Sing Sardar of vill-Ramnagar, PS- Puncha, Dist- Purulia (2) Sangram Mandal(33), S/O-Dhirendranath Mandal of vill-Sargo, PS- Barabazar, Dist- Purulia (3) Sultan Ansary(28), S/O- Jalil Ansary of vill-Bankata, PS- Manbazar, Dist- Purulia (4) Balaram Bauri (55), S/O- Gangadhar Bauri of vill-Laharia, PS-Puncha, Dist-Purulia (5) Bikram Mandal(21), S/O- Dhananjoy Mandal of vill- Bardaha, PS-Barabazar, Dist-Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51(1)(b) of the National Disaster Management Act, 2005 and arrange for its investigation.
