Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Madhab Sahis (59), S/O- Lt. Banku Sahis of vill-Puncha Sahis Para, PS-Puncha, Dist-Purulia with seizure of 23 (twenty three) bottle of "DIL KHUSH" Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (16.09.21) while I, SI Chandidas Chakraborty, along with force were performing evening mobile duty vide Puncha PS GDE No-711 Dt. 16.09.21 and acting on source information after consulting you at about 18:45 hrs reached at Puncha Sahis Para and held raid in the house of Madhab Sahis (59), S/O- Lt. Banku Sahis of vill-Puncha Sahis Para, PS-Puncha, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Madhab Sahis failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested and also 23 (twenty three)of "DIL KHUSH" Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled out of which 01 (One) bottle "DIL KHUSH" collected as a sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo and handed a copy of the same to arrestee.

The arrested accused namely Madhab Sahis (59), S/O- Lt. Banku Sahis of vill-Puncha Sahis Para, PS-Puncha, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1016 Mantu Murmu Das and (2) C/580 Pradip Kr. Bag and both of Puncha PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Madhab Sahis (59), S/O- Lt. Banku Sahis of vill-Puncha Sahis Para, PS-Puncha, Dist-Purulia under proper section of law.
