Sir,

I, Amaresh Das, Sub-Inspr. of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles (i) 06 (six) domestic LPG cylinders of HP Ltd. company fully loaded with LPG in sealed condition (ii) 03 (three) small cylinders approx 05 kg local made M.T. (iii) 01 (one) small gas cylinder local made M.T approx 2.5 kg (iv) 03 (three) apparatus having length of approx 3 inch, appearing to have been made of copper & steel used for re-filling gas from one to another cylinders (v) 01 (one) black colour mobile model no. S21, IMEI No. 355368/11/660986/0 & EMI No. 335369/11/66098679 with two SIM no. 9064898690 (Jio) and SIM No. 9547807950 (Airtel) to the effect that today on 09.09.2021 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, C/88 Pradyut Mandal, HG/1427 Benimadhab Char and HG/1590 Bishnupada Mahato had been to Purulia(M) PS and submitted one requisition to IC Purulia(M) PS for rendering assistance and noted the information at Purulia(M) PS vide Purulia(M) PS GDE No.392 dtd. 09.09.2021 at 09:35 hrs. Thereafter we along with officer and force of Purulia(M) PS left for Golkunda more under Purulia(M) PS to work out the information. On arrival at Golkunda more at about 12:35hrs, I asked two local people viz. (1) Pradip Bauri s/o Jiten Bauri of village Jalika, PS. Purulia (M) PS Dist. Purulia (2) Sampad Chatterjee s/o Haradha Chatterjee vill. Golkunda, PS. Purulia (M), Dist Purulia (3) ASI Kishor Das of Purulai (M) PS to assist us with a view to work out the credible information also for holding raid, search and seizure in the shop of one Kripamoy Rajwar s/o Radhanath Rajwar, vill. Jalika, PS Purulia(M), Dist Purulia. Prior to holding raid in the shop, we noticed huge nos. of domestic LPG cylinder kept inside the shop along with apparatus which is being used for refilling LPG from big cylinder to small cylinder. On asking to one Sibram Rajwar (elder brother) s/o Kashinath Rajwar of vill. Golkunda at present Jalika, PS. Purulia(M), Dist. Purulia. It could be learnt those cylinder were stored by his brother Kripamoy Rajwar for selling the same to the local people in a high price in lieu of money. By such business he is causing wrongful gain and causing loss of Govt. revenue as well as depraving the acquittal license. Also learnt that the place of shop of LPG cylinder in under position of Kripamoy Rajwar.

In absence of stock holder Kripamoy Rajwar non turned up before me to produce any valid document in support of such illegal business of any satisfactory account in support of such stock of LPG cylinder as well as his position. Hence issued notice to his elder brother Sibram Rajwar s/o Kashinath Rajwar of vill. Golkunda at present Jalika, PS. Purulia(M),


Dist. Purulia and held raid accompanied with officers & force with the active assistance of his elder brother Sibram Rajwar and seized the above noted Gas cylinder & re-filling under proper seizure list in presence of elder brother of Kripamoy Rajwar from the shop of gas repairing yeard Kripamoy Rajwar in between 13:05 hrs and 14:05 hrs.

In course of local enquiry it revealed that said Kripamoy Rajwar is running such clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license, only for causing his wrongful gain and causing loss of revenue to Govt. as well as local consumers/ customer. As such he violated provisions laid in rule 3 of West Bengale cooking gas (Licesesing & control order) 1985. Hence he come under the purview of EC Act and has committed an offence punishable the u/s u/s 7(i)(a)(ii) of E.C.Act (X)1955.

I therefore, pray before you the started a case under proper section of law against accused Kripamoy Rajwar ^{(2B) & s/o} Kashinath Rajwar of vill. Golkunda at present Jalika, PS. Purulia(M), Dist. Purulia

As per order of Dy.SP(DEB), Purulia ASI Prabir Mukherjee of DEB, Purulia will investigate the case.
