1. That ,the Complainant happens to be a permanent resident village- Sindurpur, P.O – Sindurpur, P.S – Purulia(M), in this district having his hearth and home there at.
2. That on 01/09/2021 at about 6.30 am when the complainant and his father went to see their cultivated land in the locality both of them saw that the above named accused person namely Akbar ansary tried to dislocate the water to their own land and when the complainant protest the same they started to quarrel with us but my father tried his best to separate us and at the same time accused akbar ansary pushed my father harshly and my father fell down on the ground and I was also been got teeth bite by akbar on my lower chest and when my father was returning home from the cultivated land on the way all the above named accused persons assaulted my father with lathi and my father fell down on the ground and with the hue and cry of my father, the complainant and his wife namely Asima Bibi ,complainant's younger brother namely Anwar Ansary reached in the place where complainant's father is being assaulted by the aforementioned accused and at the same time the complainant's wife is being assaulted with lathi by Akbar and Rajesh and with the arrival of village people all the above named accused perons fled way and my father was being admitted to Purulia Medical college for better treatment and rest all of us were being treated at Kustour BPHC.
3. That on the next day the complainant had been to the Purulia (M) P.S and the complainant narrated the matter before officer on duty of Purulia (M)P.S and the same was reduced in writing and was submitted to the Police officer of Purulia (M) P.S on 02/09/2021 but as no specific case has been lodged against the accused till date,and thereafter your Petitioner/Complainant intimated the matter in writing before Superintendent of Police, Purulia on 10/09/2020 but that too failed to evoke any response.
4. That the accused persons have committed several offences of the Indian Panel Code which warrant police investigation into the case

It is therefore ,prayed that your Honour may graciously be pleased to forward the instant petition of complaint to the I.C Purulia(M) P.S as envised U/S 156(3) Cr.P.C with a direction upon him to cause investigation into the case treating the petition of complaint as an F.I.R
