- 2.---That from the very begining of starting of conjugal lief, the accused persons were not happy with the dowries which were not happy with the dowries which were brought by the complainant to her matrimonial home and over that



over that issue the accused persons used to taunt her and also used to through abusive and objectionable languages aiming the widow mother and brothers of the complainant.

3.——That however the complainant bearing all such torture on the exception that there would develop good sense in the mind of accused persons, but such illtreatment and torture started agrivated day to day.

4.\_\_\_That very short period from the date of marriage of the complainant, The accused No. 1 and 2 after making criminal conspiracy the accused No.1 put pressure upon the complainant to bring a sum of Rs.50,000/- from her father house. And when the family members of the complainant expressed their inability to meet any further demand, hearing the news the accused persons became furious and started more torture upon the complainant and deprived her from all necessities and as such cruelty and harassment made the life of complainant horriable and restless. 5 .--- That in the month of Baishakh 2019, the complainant was bleesed with a kennintexhology female baby . After birth of new born baby the accused No.1 could not take which such in fact needy. The complainant requested the accused No.1 to arrange necessary arrangement like milk, medicine etc.but the accused No.1 refused. Then widow mother of the complainant had to make necesary arrangment for new born baby.



6.---That on 20th day of Baishak 2019 the accused Mo.1 assaultedthe complainant and drove her from their housewith her minor baby. Then the complainant any how came to her father house at village-Chepra stated all facts to her family members and since then the complainant and her baby are in the houseof her father.

7.---That the complainant and her family members
requested the accused No.1 and other accused persons to
keep the complainant and her baby in their house but
the accused persons refused to keep the complainant and
her baby without full-fill the demand.

8.---That accused No.1 is the husband of the complainant Ac cused No.2 is father-in-law, Accused No.3 is mother-in-law, accused No.4 to 6 are the sister-in-law of the complainant, Accused No.7 and 8 are the husband of accused No.4 and 5 accused No.9 is the 2nd wife of husband of the complainant and accused No.10 and 11 are the parents of the 2nd wife of accused No.1

9.---That the accused No.1 after turning the complainant out from the house of the accused No.1 and instigating by other accused persons for 2nd time marriage to one Rohima Khatun D/o 5k.Akkas resident of village Hariharpu runder P.S.Para, Dist.Purulia, Hearing the above news, the complainant and witnesses No.2 and 3 has been to house of accused No.10 and 11 requested them with folded hands not to solemnized marriage to her daughter



(Rohima Khatun accused No.9) with accused No.1 (Sk. Jamshid), and Sk.Jamshid has already married the complainant. In response of the request of accused No.10 and 11 with the active convence of accused No.1 marriage was solemnized in very silent manner on 01.07.21 in the house of accused No.1 at village Hutmura under P.S.Purulia (M), When the complainant and witnesses learned about the marriage of Sk.Jamshid with Rohima Khatun .And Sk. Jamshid would take 2nd marriage with Rohina Khatun and tried to stop it at their best but in vain.

De it mentioned here said marriage was also performed like 1st marriage as per customs prevelling in their society. The complainant reported the matter on the following date before Police personal of Purulia (M)P.S. and police assured the complainant for proper action.

10.---That after few days, when the complainant came  $t_0$  learn that no case has been started against the accused persons. Then the complainant informed the incident  $t_0 \leq P$ . Purulia but off no good.

11.---That the accused persons have committed several criminal offence for which they are liable to be convicted.

12.\_\_\_That the complainant is to poor and she is
