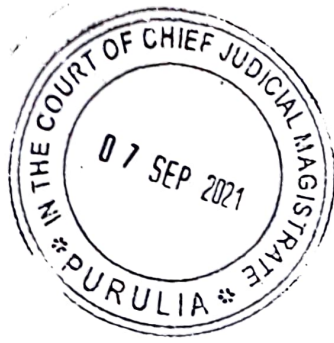

The above name complainant begs to state as follows:-

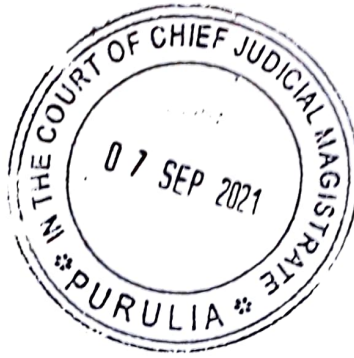
1. That your complainant is the resident of village & P.O. Ghangha, P.S.- Purulia (M), Dist.- Purulia and within the jurisdiction of this Ld. Court.
2. That your complainant was married with one Chandmuk Mahato, S/O Rasun Mahato, resident of Village Leda, P.O. – Sardaha, P.S. - Pindrajora, District Bokaro on dated 03.08.2020 (corresponding to 18th day of Shrabana 1427 B.S.) as per Hindu rites and customs prevalent in their society and their marriage was solemnized at the house of your petitioner at village & P.O. – Ghangha, P.S. Purulia (M), District Purulia.
3. That at the time of marriage the mother of your petitioner gave a sum of Rs 80,000/- (Rupees eighty thousand), gold ornaments weight 2 Bhories, Silver ornaments weight 6 Bhories, utensils and furniture's etc. as per demand of the accd. No 1 and his family members.
4. That after solemnization of marriage the accd No 1 took your petitioner to his residential house at village Leda, P.O. Sardaha, P.S. Pindrajora, District Bokaro(Jharkhand) and started living there as husband and wife and their marriage was duly consummated.

5. That after expiry of two month of peaceful matrimonial life the accd. No 1 and his family members demanding further dowry of Rs 1,00,000/- (Rupees One Lakh) from your complainant with an excuse to set up a business.
6. That your complainant showed the unablensess of her widow mother to provide/fulfill the further demand at this accd. No 1 and other accd. persons being vexed and angry intensified the quantum of torture upon your complainant day after day.
7. That the accd. No 3 Junpuki Mahato used to abuse your petitioner oftenly with reason futile and at her instigation accd. No 1 compelled to your petitioner to remain in Chala Ghar alone and also did not provide fooding and clothing properly even did not providing any medical assistance at the need of your complainant.
8. That your complainant tolerated all sorts of physical and mental torture cherishing a false hope in the corner of the mind that good day shall prevail. But lastly on 14.05. 2021 (corresponding 30th Baishak 1428 B.S.) accd No 1 along with other accd. persons assaulted your petitioner with fist and blows and drove your complainant out of their house.
9. That somehow your complainant came to her house at village Ghanga within P.S. Purulia (M), District Purulia narrated the entire story to the relatives and villagers. Since then your petitioner is at her mother's house at village Ghanga, P.S. Purulia (M), District Purulia.
10. That all of sudden on dated 19.08.2021 at about 11:30 A.M. accd No 1 with other accd persons came to the house of your complainant at village Ghanga and started to abuse your complainant at this your complainant raised objection being objected accd. No 1 assaulted your complainant by fist and blows and felt your complaint to the earth by holding the locks of hair of your complainant and putting jerk and other accd. persons instigated accd No 1 and threatened

your complainant in dire consequences. Hearing the hue and cry the villagers/ witness came and the accd. persons fled away.

11. That thereafter your complainant reported the matter to the local P.S. at Purulia (M) and Superintendent of Police Purulia on dated 26.08.2021 but till today not any action has been taken by the police against the accd. persons. So your complainant take shelter before your Honours Court.
12. That the accd. person have committed the offence and they are liable to be punished accordingly.
13. That your complainant is a poor lady and she has not in position to pull or conduct of the complain case for all such reasons the police case is desirable.

It is therefore prayed that your Honour may graciously be pleased to control the situation and unfold the truth, this complain petition may kindly be sent to the officer-in-charge of Purulia (M) P.S. to treat this written complain as F.I.R. and to investigate the same U/S-156(3) Cr.P.C. for the ends of justice.
