The complainant above named most respectfully I beg to state that the complainant is a hawker of small readymade garments and on particular date of the week the complainant used to go to different villages within Purulia (M) Police Station by his family motorcycle and go out in the morning and return in the evening after selling the garments.

That on the date of occurrence in the morning the complainant went out to sell his Garments in village Tatari and its surrounding villages. on that day he could sell the garments of only rupees 500/- (five hundred) and garments of about rupees 15000/- (fifteen thousand) were unsold and at about 6 p.m. he was returning to his home by the said motorcycle loaded with the unsold garments and when he was crossing the road near opartanr near village Tatari some persons having Lathis and other weapons in hand attacked the complainant on common intention and Gheroud him and started to assault him by fist, blows, kicks and dashed him in the ground and caused him pain injuries and some bodies struck his motorcycle by Lathi and damaged it. The complainant identified them to be Sk. Firat, Sk. Julfikar, sk. Sajan of village chepra and sk. Asiruddin@ ashua, Monpura bibi, sk. Sajid of village Tatari and Rajekun Bibi, Sk. Karimul of village Natundi as written above the said miscreants tried to kill him but on the cry of the complainant the witness reached there (except witness sk. Abul) and they shaw the accused persons and saved the complainant and lift him and his motorcycle and asked the complainant to take rest and thereafter the witness took him to his house

at Hutmura. On the following day the complainant went to Purulia Sadar Hospital for treatment and the doctor there examined him and prescribed some medicine.

That on the same day the complainant went to purulia(M) police station and lodged complaint but the police officer there did not acknowledged the complaint for which the complainant sent the complaint by registered post and waited for the police action but the police of purulia(M) P.S. did not take any action so the complainant made a forwarding letter along with the copy of petition to the superintendent of police, Purulia on 01-09-2021 but till now the S.P. Purulia has not taken any action on the complaint of the complainant for which the complainant has filed this complaint before your honour and prays that the complaint may kindly be sent to the officer in charge of the Purulia(M) police station directing him to start necessary case against the culprits and to investigate and report.

That the offence committed is cognizable and the complainant is a poorman and has no means to conduct the case on his own capacity and it is submitted the offence be investigated by the police.
