Complaint against Satyajit Mahato (30 yrs) S/O Babulal Mahato of Vill-Hulka, PS- Purulia (M), Dist-Purulia to start a cog case u/s 46 A (c) of Bengal Excise Act. 1909.

Sir,

In producing herewith one arrested accd. person namely Satyajit Mahato (30 yrs) S/O Babulal Mahato of Vill-Hulka, PS- Purulia (M), Dist.- Purulia with seizure list and seized articles.

I beg to submit that today (16.09.2021) while I was detailed to perform mobile duty in PS area along with force i) C/06 Debdas Mukherjee, ii) NVF/0068 Mahanta Mahato & iii) NVF/ 969 Pralay Mahato all of Purulia (M) PS & Purulia (M) PS C.C. No 2696/21 Dt. 16.09.2021 and GDE No 684 Dtd. 16.09.2021. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Foreign Liquors. Subsequently, I informed you and as per your direction, I rushed to the spot that is Annapurna Hotel near Sadhu Ashram Morh under Hulka village and after arriving at the spot and as per instruction conducted raid in the Hotel under this PS at 17:50 hrs. During the raid 2/3 persons fled away from this hotel and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Foreign Liquors for selling illegally from his hotel so that he could gain more amount from the selling of (liquors) Foreign Liquors. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Foreign Liquors at his Hotel. Subsequently, I seized (i) 02 sealed bottles foreign liquor each containing 650 ml., MRP 130/- per bottles which is styles as "King Fisher" (ii) 01 sealed bottle foreign liquor each containing 750 ml., MRP 580/- which is styles as "Officer Choice" (iii) 03 sealed bottle foreign liquor each containing 180 ml., MRP 153/- per bottles which is styles as "MC Dowells No-I (Rum)", (iv) 02 sealed bottle foreign liquor each containing 180 ml., MRP 174/- per bottles which is styles as "MC Dowells No-I Original (Whisky)", (v) 01 sealed bottle foreign liquor containing 180 ml., MRP 174/- which is styles as "Imperial Blue (Whisky)", (vi) 02 sealed bottle foreign liquor each containing 180 ml., MRP 241/- per bottles which is styles as "Royel Challenge", and kept 01 sealed bottles of every foreign liquors as sample from 11 (eleven) bottles under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Satyajit Mahato (30 yrs) S/O Babulal Mahato of Vill-Hulka, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his wheelbarrow. Under the fact and circumstance kindly take necessary lawful action against Satyajit Mahato (30 yrs) S/O Babulal Mahato of Vill-Hulka, PS- Purulia (M), Dist- Purulia.
