Respected Sir.

Today (17.09.2021) during my day mobile duty towards Purulia- Ranchi road and after being informed by the duty officer of Purulia (M) PS regarding road blocked at Sindri chasmorh on Purulia-Ranchi road (NH-32) and the road was obstructed by the some followers of Adibashi Kurmi Samaj who have decided to observe "Duare Karam" (Observance of Karam festivals on road) regarding the show protest against the announcement of "Sectional Holiday" instead of "General Holiday" in c/w their Karam festivals.

After receiving the information immediately I along with force as i) C/297 Apurba Pandey, (ii) NVF/0068 Mahanta Mahato all of Purulia (M) PS vide C.C. No 2703/21 and GDE No 714, Dt. 17.09.2021 rushed to the spot at about 11:15 hrs. and found that the road has been blocked by the rabble/ followers of Kurmi Samaj, about 100 people of different villagers. After forming unlawful assembly under the leadership of (i) Sasanka Sekhar Mahato, Savapati State committee of Kurmi Samaj of Vill- Garafusra (ii) Satish Mahato Anchal Savapati Kurmi Samaj of Garafusra G.P of Village Chirka (iii) Jiten Mahato S/O Not known of Vill-Gandhudih (iv) Nirmal Mahato S/O not known of Golbera (v) Bhagyacharan Mahato S/O Not known of Vill-Sindri all of PS-Purulia (M), Dist-Purulia (W.B), Subsequently vehicular traffic was totally disrupted and seized along the Purulia-Ranchi road (NH-32). Ongoing buses, Trucks and other vehicles were stopped. We requested the above noted leaders to withdraw the blocked but they paid no heed to our words and they raised slogans against State Government for General Holiday in c/w their Karam festival. I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal and deter my duty. I along with force started to disperse them form the road but the road blockers obstructed them adamantly from the discharge of their public functions. After the prolonged discussion the mob withdraw the blocked at 11:55 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. On local enquiry I managed to collect the name and address of some agitating people/ followers of Kurmi Samaj as noted above. Therefore the above noted persons committed an offence U/S -341/188/186/283 IPC & 8B of National Highway Act- 1956 under the leadership of supra noted persons ergo. So a specific case may kindly be initiated against them and arranged for its investigation.
