





In the matter of an Application u/s 156 (3) Cr.P.C.

The Complainant named above begs to state as follows:-


- 1) That the Complainant is a reputed artist of Purulia and used to perform in 'Theatre' and is also devoted to many cultural activities.
- 2) That on 19/07/2021 the Complainant came to Purulia to visit the LIC Office, near Purulia Bus Stand, at Purulia for some personal works. On that day after completion of his work at about 4 p.m, the Complainant went to the nearby saloon of one of his friend i.e. the Witness no-2 and after gossiping with him for a while, when the Complainant was going towards the Purulia Bus Stand to avail the bus, suddenly the Accused Persons with some unknown miscreants arrived there and wrongfully restrained the Complainant and started to abuse him with filthy languages and started to threaten him with dire consequences.
- 3) That at that time some unknown miscreants riding in a vehicle reached there and all the Accused Persons forcibly pushed the Complainant into that car and took him to a house at Sarkar Para, Purulia where he was wrongfully confined and assaulted by all the Accused Persons with fists, blows and kicks for which he sustained injuries all over his body. The Accused Persons at that time started to demand a bulk amount of 14 Lakhs from the Complainant on the plea that the younger brother of the Complainant took the amount as loan from them. The Complainant became astonished and informed them that his younger brother has already been died before 3 years ago and he was not aware of any such loan transaction of his brother. Hearing such news, the Accused Persons became very much furious and started to exert physical torture upon the Complainant. At that time they also threatened the Complainant that they would cut out his kidneys and would sale out the same to fulfil their claim.
- 4) That the Accused Persons then pressurised the Complainant to put his signature on some blank papers including some Stamp Papers and some Demy Papers. The Complainant at that moment became so much panic-stricken and nervous. He even





could not dare to raise hue and cry. The Accused Persons intentionally put the Complainant in fear of injury of his life and thereby dishonestly induced the Complainant to deliver all of his valuable documents lying in his side bag viz. Pass Book of State Bank of India, Baram Branch vide Account no-37616467995, Cheque Book of the very SBI Account as aforesaid and his Aadhar Card vide no-8896 6823 7602. They also put the Complainant in fear of grievous hurt and thereby induced him to put signatures also in all blank cheques of the Cheque Book(SBI) which was kept in his bag and out of fear he was compelled to put his signatures on those papers as per their demands.

- 5) That the Accused Persons also forcibly snatched away two mobile phones of the Complainant viz. one of Samsung Company(Black Colour) vide mob no-8336927014 and another of OPPO Company.
- 6) That keeping the aforesaid documents and articles of the Complainant under their custody, the Accused Persons leave the Complainant with a direction to pay unto them a sum of Rs.14 Lakhs. The Complainant anyhow managed to save his life on that occasion. The Complainant after reaching his house informed the matter to his parents and friends and also went to Joypur P.S. to lodge a Complaint but the police officer-in-duty directed him to go to Purulia(T) P.S. as the incident took place under the Jurisdiction of that P.S.
- 7) That after the very incident the Complainant became seriously ill due to such physical torture meted out by the Accused Persons and thus he was examined by Additional M.O. of Joypur BPHC on 20/07/2021 and subsequently on 27/07/2021 also. After being treated by the Additional M.O. of Joypur BPHC on 20/07/2021 and after some recovery of his physical condition, the Complainant along with his friends had been to Purulia(T) P.S. on 22/07/2021 to lodge a Written Complaint against the Accused Persons and after reaching there they submitted the Written Complaint and also informed the matter to the concerned police and accordingly the Police Personal at the P.S. who was on duty at the relevant time assured him that they will take appropriate step against the Accused Persons. But as no step was taken by the Police, the Complainant sent his Written Complaint to the Purulia(Γ) P.S. through Registered Post on 24/07/2021.
- 8) That after waiting for a considerable period and after approaching several times, when the Complainant found that the police of Purulia(T)P.S. practically has not taken any step whatsoever against the Accused Persons, the Complainant on 26/07/2021 submitted a Written Complaint before the Superintendent of Police, Purulia but even in spite of all these endeavours of the Complainant, no step has



been taken by the police and as such the Complainant is being compelled to lodge this Petition u/s 156(3) Cr.P.C. before Your Honour's Court.

- 9) That the Complainant apprehends that the Accused Persons may dishonestly use those blank papers. Cheques signed by the Complainant for manufacturing any false documents and may use the same against the Complainant.
- 10) That the Accused Persons are very much rowdy in nature and are engaged in various immoral activities. Moreover several criminal cases have been instituted and/or pending against the said Accused no-1 in this Court. Be it mentioned here that the Accused Persons are constantly giving out threat to the Complainant over phone and are often threatening him not to file any case.
- 11) That be it mentioned here that after the incident the Accused Person no-1, by using the contact number of several persons saved in the said mobile of the Complainant, started abusing and/or harassing several friends of the Complainant, for which one Sonali Banerjee filed a Criminal Case against him at Gorabazar P.S.
- 12) That the Accused Persons have thus committed offences punishable u/s 143/323/341/342/347/352/384/385/387/506/34 I.P.C.
- 13) That the Complainant being a helpless person is unable to arrange for producing the Witnesses in Court at his own cost. Moreover in the instant case various valuable documents are to be recovered and seized and the recovery of the snatched Mobile Phones and the Cheque Book. Anadhar Card of the Complainant and other documents as aforesaid are yet to be done which could not be possible without police help.

In the circumstances stated above, it is therefore prayed that Your Honour may be graciously pleased to send this Complaint to the I.C. of Purulia(T) P.S. with a direction to treat the same as FIR and to start investigation in the matter and to prosecute the Accused Persons as per law.
