



The above name complainant begs to state as follows:

- That the complainant is the legally marriage of the accused 1) no. 1 Paltan @ Milan Mahato and their marriage was solemnized on 14/08/2020 as per Hindu rites and customs as prevalent in their community by putting on vermilion, exchange of garlands, Home etc. and their marriage is still subsisting. And one Ganesh Mahato was the match-maker, thereafter the factum of their marriage was duly registered on 28/08/2020 as the husband of the complainant is working as Police Constable under Government of West Bengal and now posted at Tamluk P.S. At the time of marriage, as per demand of the above noted accused persons, the father of the complainant paid a cash of Rs. 3,50,000/-, Golden ornaments weighing seven bhories and also gave Devan, Almirah, Freeze, T.V. Sofa-set, utensils etc.. In-spite of that they are not happy.
 - 2) That after marriage as per their social customs the complainant was brought at her matrimonial house and started to reside therein as husband and wife along with her parents-in-laws.





That for some months after their marriage, the complainant 3) was somehow well and good at her matrimonial house. But during passage of time the husband of the complainant being instigated by her parent-in-laws, they started all sorts of inhuman, physical, as well as mental torture upon the complainant. They also even not provided proper food and clothing including daily necessities to the complainant; they also abused the complainant and her family members in filthy languages. It is to be pointed out that at the time of marriage Corona virus was being spreaded for that no reception party would be held, but on 10/12/2020 when the corona virus became downwards for that in the Gymnastic Club at Purulia arranged by the father of the complainant. And in the said occasion the husband of the complainant along with all the in-laws including relations were present. Simolentiously the husband of the complainant also arrange another party on 14/02/2021 in the matrimonial house of the complainant, where so many persons including the parents of the complainant were participated, and the manner relations between two groups were became very much co-deal.





- 4) That thereafter, the husband of the complainant taken her at his posting place i.e. the service place of the accused no1 and kept the complainant in a rented house. But from the very next day the husband of the complainant with the instigation of her parent-in-laws including the said Ganesh Mahato inflected physical as well as mental torture upon me.
- her husband have some illicit relationship with an another girl. And when the complainant asked her husband about the said girl and also protested such illegal relation then the husband of the complainant mercilessly assaulted the complainant and also threatened her in various consequences. And thereafter persistent torture was continued upon the complainant which gradually became unbearable for the complainant. In-spite of that the complainant somehow managed to reside with her husband for good days.

The complainant narrated all such torture to her parents and her other relations when they tried to convince the husband of the complainant to keep her in the house of



the accused persons with proper manner and also requested the accused persons not to inflict any such torture without any laps on the part of the complainant.

6) That when such state of thing was going on the above noted four accused persons being conspiracy asked the complainant to bring a cash of Rs. 1,00,000/- from the father of the complainant as further dowry. Contrary to that the accused persons disclosed that unless the said money be paid they will not allow the complainant to stay in their house, contrary to that they would arrange second marriage of the husband of the complainant, the accused persons also disclosed that as the husband of the complainant is serving in Police Department in that case the complainant shall not be able to make any complaint against the accused persons under the law. In-spite of that the said untoward incident, the complainant tried her level best to continue her relationship with her husband and other inlaws as usual. But on 02/03/2021 all the above noted accused persons assaulted the complainant mercilessly and driven her out from the house of the accused persons.



- 7) Since thereafter the complainant is residing at her paternal house at Purulia Town. Thereafter her husband threatened the complainant with dare consequences over mobile phone.
- Persons along with some unknown persons came to the paternal house of the complainant and in course of talking in family matter they never take any initiative to bring back the complainant, but in course thereof some hot altercation taken place and the husband of the complainant before all slapped the complainant and thereafter they left the paternal house of the complainant.
- 9) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- Purulia Town P.S. against the accused persons but the said Officer-in-charge did not taken any legal action against them, then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant is under compelling circumstances is



filing this complaint before the Ld. Court for appropriate reliefs under the law.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Purulia Town P.S. for treating the same as FIR under section 156(3) for investigation.
