

In the matter of an Application u/s 156 (3) Cr.P.C.

The Complainant named above begs to state as follows:-

- That the Complainant and the Accused Persons are inhabitants of same moholla and known to each other.
- 2) That on 26/08/2021 one dispute arose in between the witness no-2 i.e. the Daughter-in-Law of the Complainant and the Accused no- 1 to 4 regarding the issue of collecting water from the water tap of the moholla. After the very incident, subsequently on the next day i.e on 27/08/2021 at about 12.30-1.00 p.m. suddenly the Accused Persons no-1 to 4 came in front of the house of the Complainant and started abusing the Complainant and her family members in filthy language. Hearing such slang abusive languages, the witness no-2 came outside of the house and protested against them for which the Accused Persons no- 1 to 4 all of a sudden started to assault the witness no-2 mercilessly with fists and blows. She started crying in pain and raised halla. Hearing hue and cry of her daughter-in-law, the Complainant reached there to rescue the witness no-2 from the clutches of the Accused Persons as aforesaid. In the mean time the Accused no-5 reached there and started assaulting the Complainant with fists, blows and kicks. At that time the Accused no-5 forcibly torn the saree and blouse of the Complainant and started to touch her private parts and thereby the Accused no-5 committed outraging her modesty. All the Accused Persons then started to assault the Complainant mercilessly for which the Complainant sustained several injuries on her person.
- 3) That moreover the Accused Persons, having knowledge that the Complainant recently had gone to a surgery of tumour in her uterus, they with intention of hurting the Complainant grieviously, they constantly kicked her in her abdomen. The Complainant failed on the ground and started screaming in pain. She also requested them with folded hands to leave her but they did not give any response to her request.
- 4) The Accused Persons also had broken the window and door of the house of the Complainant and other valuable articles of her house. At that time, some of the neighbours also rushed to the spot and seeing them to come to the spot, the Accused Persons fled away from the spot. At that time also the





Accused Persons threatened the Complainant and her family members of dire consequences.

- 5) That after the very incident, the Complainant was immediately taken to Sadar Hospital, Purulia on the very date and the Complainant was admitted therein in serious condition as she sustained serious injury on her abdomen and was treated medically therein. Subsequently on 28/08/2021 the Complainant was discharged from the hospital.
- 6) That after being discharged from the Hospital, the Complainant along with her associates had been to the Purulia(T) P.S. to lodge a written complaint against the Accused Persons and they also informed the matter to the police and accordingly the Police Personal at the P.S. who was on duty at the relevant time assured her that they will take appropriate step against the Accused Persons. But as no step was taken by the Police, the Complainant sent the Written Complaint to the I.C. Purulia(T) P.S. through Registered Post on 04/09/2021 which was delivered to concerned P.S.
- 7) That after waiting for a considerable period when the Complainant found that the police of Purulia(T) P.S. practically has not taken any step whatsoever against the Accused Persons, the Complainant on 09/09/2021 submitted a Written Complaint before the Superintendent of Police, Purulia but even in spite of all these endeavours of the Complainant, no step has been taken by the police and as such the Complainant is being compelled to lodge this Petition u/s 156(3) Cr.P.C. before Your Honour's Court.
- 8) That the Complainant being a helpless, poor and rustic widow is unable to arrange for producing the Witnesses in Court at his own cost. Moreover in the instant case various documents as well as medical papers of the injured are to be seized which could not be possible without police help.

It is therefore prayed that Your Honour may be graciously pleased to send this Complaint to the I.C Purulia(T) P.S. with a direction to treat the same as FIR and to start the investigation in the matter and to
