Barahandeb Singh of W.C Khatal, opposite Sainik School main gate, PO- Manguriya, PS- Purulia (M), Dist- Purulia to the effect that on 24.09.2021 while I PSI Suvajit Nandi along with force (1) C/50 - Chiranjit Ghosh and (2) C/188- Arup Mahato both of Purulia(T) PS, Dist-Purulia were performing Special Drive against non wearing mask vide Purulia(I) PS GDE No- 1344, Dated- 24.09.2021. During my mobile duty when myself along with force reached at Post Office more under Purulia (T) PS at 23:05 hrs and found the above persons were roaming aimlessly at Post Office more without mask. I started to detain them. On being asked the above noted persons disclosed their identity but they could not able to give any satisfactory answer for their movement on road and public place without wearing mask. So, I arrested them as per the procedure laid down in Cr. P.C and followed the latest guidelines of the Apex Court, prepared arrest memo. I also offered them medical aids, but they refused. I also offered them bail, but no sureties turned up. So having no other alternate way, I brought them to PS and put them in lockup maintaining all legal formalities.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & the State Govt. has passed an order to wear mask in the public place is mandatory and ordered to prosecute the defaulters. They violated the order duly promulgated by the government through public servants and through media etc for prevention of spreading of CORONA Virus/COVID-19. They were creating annoyance to the society & violated the govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 79-CS/2020 dated 12.04.2020 and order No- 753/III-ISS/2M-22/2020 dated 14.07.2021 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021 dated- 17.04.21, Government of West Bengal has stressed that any violation of muskl and social distance norms should be strictly dealt with.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
